## Melbourne City Link Act 1995

### NOTICE OF DECLARATION OF LINK ROAD – WESTERN LINK UPGRADE

I, the Hon. Ben Carroll MP, Minister for Roads and Road Safety and Minister administering the **Melbourne City Link Act 1995** ('the Act'), in accordance with section 61(3) of the Act, give notice that I have made a declaration under section 61(1) of the Act. A copy of that declaration is printed with this notice.

By operation of the definition of 'Link road' in section 3 of the Act, the land the subject of the declaration is now part of the Link road.

Further, upon publication of this notice in the Government Gazette, by operation of section 61(4) of the Act, the road specified in the declaration is deemed to be –

- (a) a freeway within the meaning of the **Road Management Act 2004**;
- (b) a road open to and for use by the public for passage with vehicles; and
- (c) a highway within the meaning of the **Road Safety Act 1986**.

DECLARATION OF LINK ROAD – WESTERN LINK UPGRADE

- (a) declare to be a road the land and strata listed in Schedule A and on the plan below, being land and strata to which section 61(1) of the Act applies; and
(b) state that the road described in Schedule A and on the plan below is to be treated as a freeway.

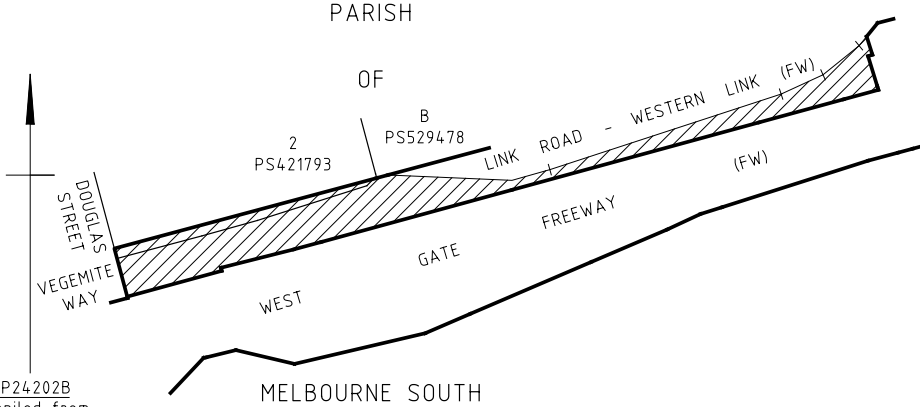
