Marine Safety Act 2010

AMENDMENT TO NOTICE UNDER SECTION 208 OF THE MARINE SAFETY ACT 2010 SPECIFYING AN ACTIVITY EXCLUSION ZONE CORRIGENDUM

I, Cameron Toy, Director Maritime Safety as authorised delegate of Safe Transport Victoria by this notice amend the notice published in the Government Gazette S 551 dated 15 October 2022 under the heading 'Notice under section 208 of the **Marine Safety Act 2010** specifying an activity exclusion zone (Notice)'.

That Notice is amended such that it now is to be read as prohibiting:

1. all persons, other than:
 - a. members, officers or personnel of Victoria Police, State Emergency Service, Ports Victoria, Parks Victoria and Safe Transport Victoria;
 - b. crew, staff and passengers on board Domestic Commercial Vessels (but not including Hire and Drive vessels), and
 2. all vessels, other than:
 - a. those operated by Victoria Police, State Emergency Service, Ports Victoria, Parks Victoria and Safe Transport Victoria, and vessels expressly authorised by members, officers or personnel of Victoria Police, State Emergency Service, Ports Victoria, Parks Victoria and Safe Transport Victoria, and
 - b. domestic commercial vessels (but not including Hire and Drive vessels)
from entering, or remaining in, the following State waters: Yarra River from Dights Falls downstream to the Southern Drip Line of the Westgate Bridge including Victoria Harbour,
- and
3. all persons, other than members, officers or personnel of Victoria Police, State Emergency Service, Ports Victoria, Parks Victoria and Safe Transport Victoria, and
 4. all vessels, other than those operated by Victoria Police, State Emergency Service, Ports Victoria, Parks Victoria and Safe Transport Victoria, and vessels expressly authorised by members, officers or personnel of Victoria Police, State Emergency Service, Ports Victoria, Parks Victoria and Safe Transport Victoria,
from entering, or remaining in, the following State waters: Maribyrnong River from Deep Creek downstream to the confluence with the Yarra River.

The amendment made by this notice comes into effect immediately. The Notice, as amended above, continues to remain in effect until 19 October 2022.
