## Environment Protection Act 2017

### NOTICE OF WASTE LEVY WAIVER NO. 2

I, Lily D'Ambrosio, Minister for Environment and Climate Action and Minister responsible for administering the **Environment Protection Act 2017** (the Act), give notice under section 146 of the Act, of a waiver of the requirement to pay a waste levy under section 145 of the Act, in accordance with the following terms.

#### 1. Authorising provision

This waiver is made under section 146 of the Act.

#### 2. Definitions

In this waiver, the following terms mean:

- a. **Affected areas**, for the purposes of section 146(2)(a) of the Act, means the following local government areas:
  - i. Ararat Rural City Council
  - ii. Banyule City Council
  - iii. Boroondara Council
  - iv. Brimbank City Council
  - v. City of Ballarat
  - vi. City of Greater Geelong
  - vii. Colac Otway Shire Council
  - viii. Glenelg Shire Council
  - ix. Golden Plains Shire Council
  - x. Hume City Council
  - xi. Indigo Shire Council
  - xii. Manningham City Council
  - xiii. Melbourne City Council
  - xiv. Moorabool Shire Council
  - xv. Moyne Shire Council
  - xvi. Swan Hill Rural City Council
  - xvii. Warrnambool City Council
  - xviii. Whittlesea City Council
  - xix. Wodonga Council
  - xx. Wyndham City Council
  - xxi. Yarra Ranges Council
  - xxii. Yarriambiack Shire Council
- b. **Affected landfills**, for the purposes of section 146(2)(c) of the Act, means any landfill which receives flood waste from the affected areas.
- c. **Emergency**, for the purposes of section 146(2)(a)(i) of the Act, means the flood event in Victoria commencing on or around 13 October 2022.
- d. **Flood waste**, for the purposes of section 146(2)(b) of the Act, means any material deposited on property by the emergency, or material damaged by the emergency that is required to be disposed of as part of the recovery from the emergency.

**SPECIAL**

**3. Waiver**

The waste levy is waived for all flood waste taken to affected landfills from the date this notice is published in the Government Gazette until 31 December 2022.

**4. Conditions**

Affected landfills must provide information on flood waste as part of their Waste Levy Statements.
