ALLOCATION OF PROPERTY, RIGHTS AND LIABILITIES OF MELBOURNE HEALTH TO NORTHERN HEALTH

Order in Council

The Governor in Council, on the recommendation of the Minister for Health made under section 248(1)(d) of the **Health Services Act 1988** ('the Act') and acting under section 248 of the Act by this Order –

1. Allocates such of property, rights and liabilities of Melbourne Health to Northern Health as specified in the sub-clauses below:
 - 1.1 all property, rights and liabilities in respect of the plant and equipment described in item 1 of Schedule 1;
 - 1.2 all property, rights and liabilities in respect of the motor vehicles of which ownership is to be transferred described in item 2 of Schedule 1;
 - 1.3 all property, rights and liabilities in respect of the motor vehicles of which lease arrangement are to be transferred described in item 3 of Schedule 1;
 - 1.4 all property, rights and liabilities in respect of:
 - (a) all medical records and medical files in whatever format;
 - (b) all other records and files in whatever format; and
 - (c) all Treatment Ordersthat relate to the treatment of patients at the Aged Persons Mental Health Program Northern/North East

DEFINITIONS AND INTERPRETATION

2. In this Order and in Schedule 1:
 - (a) the terms 'property', 'rights' and 'liabilities' have the meaning given to them by section 244 of the Act;
 - (b) the term 'Aged Persons Mental Health Program Northern/North East' means the following services and facilities at the Bundoora Centre located at 1231 Plenty Road, Bundoora:
 - a. the Bundoora Aged Persons Mental Health Unit (APMHU), known as the 'Kath Atkinson Wing'; and
 - b. the Northern and North East Aged Persons Assessment and Treatment Team (APATT);
 - (c) the term 'Treatment Order' means a 'Treatment Order' or 'Temporary Treatment Order' (as the case may be) as defined in section 3 of the **Mental Health Act 2014**;
 - (d) a reference to each of Melbourne Health and Northern Health is a reference to a public health service within the meaning of section 3 of the Act.

COMMENCEMENT

This Order comes into effect on 7 November 2022.
