Project Development and Construction Management Act 1994

NOMINATION ORDER

Order in Council

The Governor in Council with the advice of the Executive Council under section 6 of the **Project Development and Construction Management Act 1994** ('the Act') and on the advice of the Premier, by Order declares the Ground Lease Model 2 Project ('Nominated Project') to be a project to which the Act applies and, in accordance with section 7 of the Act, specifies that:

- (a) the Minister for Housing is the Minister who is to be responsible for the Nominated Project; and
- (b) the Chief Executive Officer, Homes Victoria, being a body corporate established under section 9 of the **Housing Act 1983**, is to be the facilitating agency for the Nominated Project.

This Order comes into effect on the date it is published in the Government Gazette.

Order in Council

The Governor in Council with the advice of the Executive Council under section 8 of the **Project Development and Construction Management Act 1994** ('the Act') and on the recommendation of the Premier, by Order specifies, in respect of the Ground Lease Model 2 Project, a nominated project under section 6 of the Act ('Nominated Project') that:

- (a) the following provisions of Part 3 of the Act are to apply in relation to the Nominated Project: sections 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and 28;
- (b) the following provisions of Part 3 of the Act are to apply in relation to the Chief Executive Officer, Homes Victoria, being a body corporate which is established under section 9 of the Housing Act 1983 which is the facilitating agency for the Nominated Project: sections 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and 28;
- (c) the following provisions of Part 3 of the Act are to apply in relation to the Minister for Housing, the responsible Minister for the Nominated Project: sections 19, 20, 22, 23 and 24.

This Order comes into effect on the date it is published in the Government Gazette.
