Transport (Compliance and Miscellaneous) Act 1983

AMENDING CONDITIONS No. 3/2022 MADE UNDER SECTION 220D

The Head, Transport for Victoria, the entity established under section 64A of the **Transport Integration Act 2010**, hereby determines, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, the following conditions (the Amending Conditions No. 3/2022) which amend the Conditions under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983** published in the Victoria Government Gazette No. S 731 dated Tuesday 21 December 2021, effective 1 January 2022, as amended by amending conditions published in the Victoria Government Gazettes No. S 362 dated Friday 15 July 2022, effective 16 July 2022, and No. S 428 dated Friday 26 August 2022, effective 26 August 2022.

The Amending Conditions No. 3/2022 take effect on the day they are published in the Government Gazette.

AMENDING CONDITIONS No. 3/2022

The Conditions under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983** published in the Victoria Government Gazette No. S 731 dated Tuesday 21 December 2021, effective 1 January 2022, as amended by amending conditions published in the Victoria Government Gazettes No. S 362 dated Friday 15 July 2022, effective 16 July 2022, and No. S 428 dated Friday 26 August 2022, effective 26 August 2022, are amended as follows:

1. For Clause 3.54 substitute –

'To be eligible for a primary or secondary school student concession a customer must -

- (a) be 5 to 18 years old (inclusive); and
- (b) be a full-time primary or secondary school student who
 - (i) attends a primary or secondary school in Victoria; or
 - (ii) attends a primary or secondary school in New South Wales or South Australia and resides in Victoria.'.
- 2. In Clause 3.55 for '3.54(a) and one of paragraphs 3.54(b) and (c)' substitute '3.54'.
- 3. For Clause 3.129(a) substitute –

'a Daily paper ticket which may be used on metropolitan services in zones 1 and 2 at metropolitan Premium Railway Stations, myki-enabled regional bus services and other bus services within the Mornington Peninsula Shire; or'.

- 4. In Clause 3.142, after 'Where touch off occurs' **insert** 'at or'.
- 5. In Clause 3.152(e), for 'Point' substitute 'Port'.
- 6. For Clause 4.186 substitute –

'To be entitled to purchase a Student Pass for travel a customer must -

- (a) be a full-time primary or secondary school student who
 - (i) attends a primary or secondary school in Victoria; or
 - (ii) attends a primary or secondary school in New South Wales or South Australia and resides in Victoria; or
- (b) be a full-time primary or secondary school student approved by the Victorian Registration and Qualifications Authority to be a home-schooled primary or secondary school student; or
- (c) be a secondary student undertaking a full-time Victorian Certificate of Education (VCE) or Victorian Certificate of Applied Learning (VCAL) or Victorian Pathways Certificate (VPC) course at a university or Technical and Further Education (TAFE) institution that is listed on the PTV website or a website maintained by the Department of Transport.'.
- 7. In Clause 6.3 after 'the ticket' **insert** 'unless an exception is specified in the Victorian Regional Bus Fares Supplement'.
- 8. For Clause 6.23 substitute –

'To be entitled to purchase a Regional Bus Student Pass for travel a customer must -

- (a) be a full-time primary or secondary school student who -
 - (i) attends a primary or secondary school in Victoria; or
 - (ii) attends a primary or secondary school in New South Wales or South Australia and resides in Victoria; or
- (b) be a full-time primary or secondary school student approved by the Victorian Registration and Qualifications Authority to be a home-schooled primary or secondary school student; or

- (c) be a secondary student undertaking a full-time Victorian Certificate of Education (VCE) or Victorian Certificate of Applied Learning (VCAL) or Victorian Pathways Certificate (VPC) course at a university or Technical and Further Education (TAFE) institution that is listed on the PTV website or a website maintained by the Department of Transport.'.
- 9. For Clause 11.91 substitute –

'For the purposes of these Conditions a reference to public holidays refers to the days appointed as public holidays under sections 6, 7 and 8 of the **Public Holidays Act 1993** (except any public holidays that do not apply throughout the whole of Victoria).'.

10. In the footnote to TABLE I, for '\$34.40' substitute '\$38.40'.

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Conditions and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.
