NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

Parks Victoria as the declared waterway manager for Yarra River upstream of the port waters of the Port of Melbourne hereby gives notice under section 208(2) of the **Marine Safety Act 2010** that all persons and vessels not registered to take part in the Christmas Festival Row Ho Ho event are prohibited from entering and remaining in the following waters.

Waters of Yarra River – approximately 50 metres downstream of the Evan Walker Bridge on the northern bank, approximately 35 metres wide and extending 5 metres from the northern bank.

The exclusion zone will be in effect from 10.00 am Friday 25 November to 10.00 am Wednesday 28 December 2022.

Set Aside Determination – Regulation 11(1)

Local Port of Port Phillip
