The Minister for Planning has approved Amendment C211hume to the Hume Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment rezones 2–6 Phillip Street, Dallas from the Industrial 3 Zone (INZ3) to the Commercial 1 Zone (C1Z) and apply the Incorporated Plan Overlay Schedule 7 (IPO7) and apply the Environment Audit Overlay (EAO).

Amendment C195yran

The Minister for Planning has approved Amendment C195yran to the Yarra Ranges Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment replaces the Local Planning Policy Framework of the Yarra Ranges Planning Scheme with a new Municipal Planning Strategy at Clause 02, a modified Planning Policy Framework at Clauses 11–19 and a selected number of local schedules to overlays and operational provisions in a manner consistent with changes to the Victoria Planning Provisions introduced by Amendment VC148.
