ORDER MODIFYING AND ADAPTING SECTIONS OF THE **ELECTORAL ACT 2002** FOR THE SUPPLEMENTARY ELECTION FOR THE DISTRICT OF NARRACAN 2022

1. Title

This Order is called the **Order modifying and adapting sections of the Electoral Act 2002 for the supplementary election for the district of Narracan 2022**.

2. Authorising provision

This Order is made under section 72(4)(b) of the **Electoral Act 2002**.

3. Commencement

Under section 4A(3)(b) of the **Subordinate Legislation Act 1994**, this Order is effective from the beginning of the day on which it is published in the Government Gazette.

4. Purpose

- (1) On 20 November 2022, the election for the district of Narracan for which the election day was 26 November 2022, failed by force of section 72(1)(a) of the **Electoral Act 2002**.
- (2) As a result, section 72(2)(c) of the **Electoral Act 2002** requires the person who issued the writ for that election to issue a new writ for a supplementary election for the district of Narracan.
- (3) This Order modifies and adapts the sections of the **Electoral Act 2002** that are specified in the Schedule, being modifications and adaptations that are necessary by reason of the fact that the supplementary election for the district of Narracan will be held on a day later than the election day appointed for the election that failed.

5. Modifications and adaptations

- (1) Subject to Clause 5(2), a provision of the **Electoral Act 2002** specified in Column 1 of the Table in the Schedule is modified and adapted as specified in Column 2 opposite that provision.
- (2) The modifications and adaptations made by this Order apply only in relation to the supplementary election for the district of Narracan, which is to be held as a result of the failure of the election for that district that occurred on 20 November 2022.
