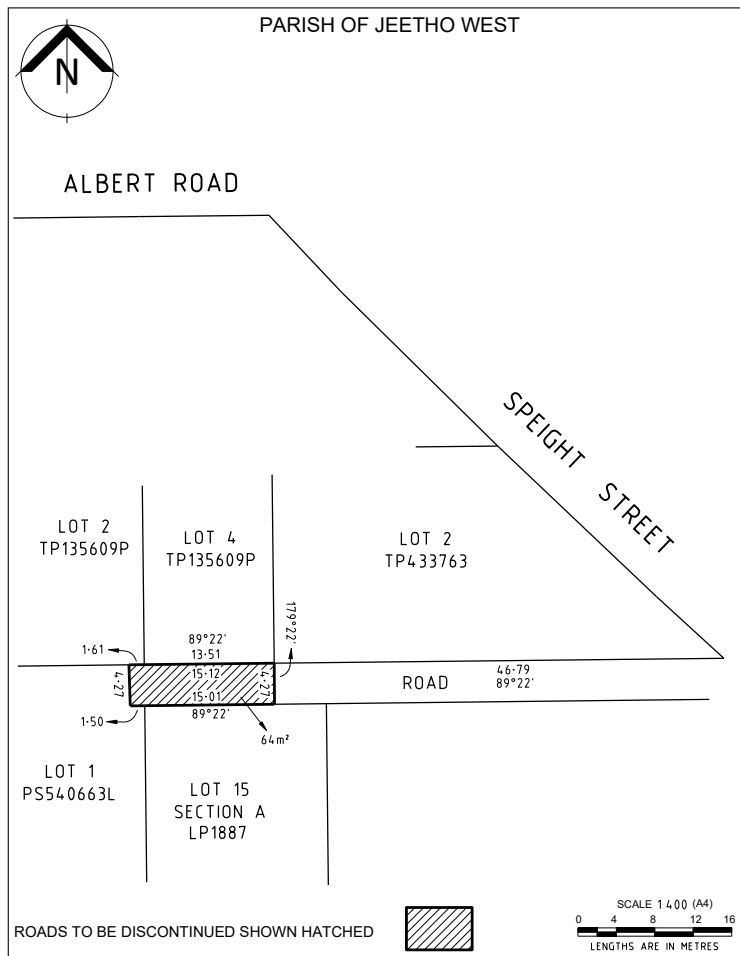

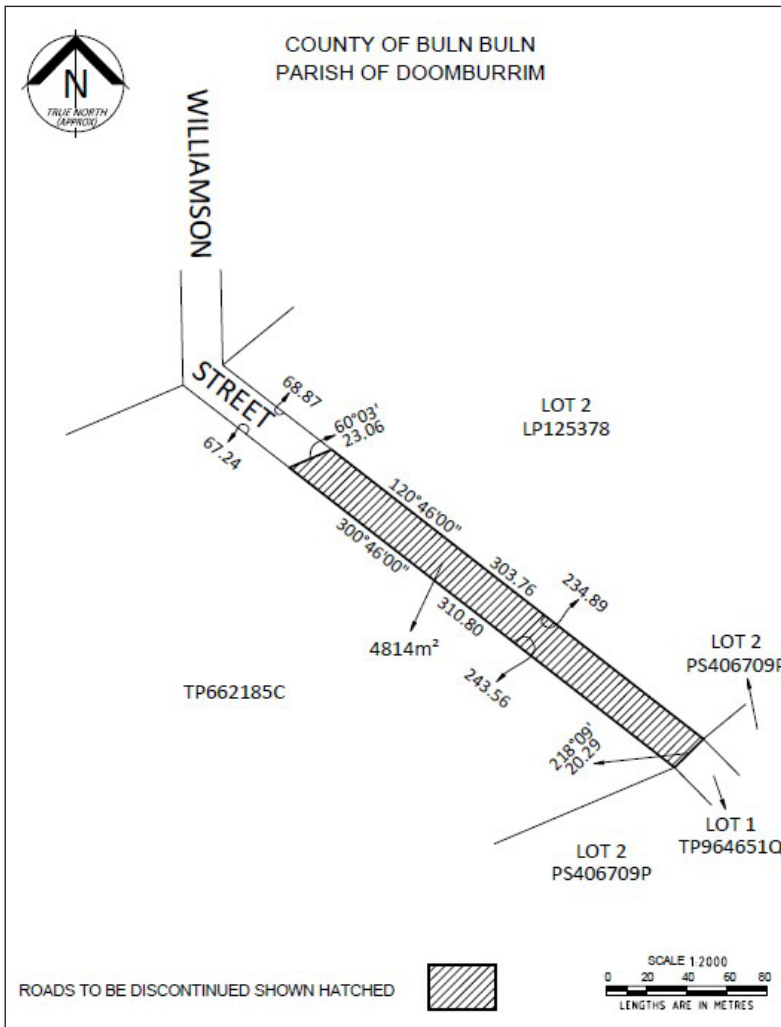

4 **Declaration**

I, Minister for Housing, Colin Brooks pursuant to section 142JA of the **Housing Act 1983** declare the Homes Victoria Affordable Housing Rental Scheme to be a Victorian Affordable Housing Program.

Participation in the Affordable Housing Rental Scheme is subject to the requirements set out in relation to the Victorian Affordable Housing Program in any relevant VAHP Determination.

5 **Scope and Purpose of the Victorian Affordable Housing Program**

The Affordable Housing Rental Scheme will provide affordable rental homes to low-to-moderate income Victorians as well as some essential government funded service delivery workers in regional Victoria. The eligibility criteria for the Affordable Housing Rental Scheme are to be set out in the VAHP Determination issued in relation to that scheme.

Homes Victoria determines pursuant to section 142JB of the **Housing Act 1983** that the Affordable Housing Rental Scheme (which was declared a Victorian Affordable Housing Project pursuant to the VAHP Declaration) will have the specific policy and operational settings detailed in Table 1 below.

The Affordable Housing Rental Scheme will provide affordable rental homes to low-to-moderate income Victorian residents as well as some essential government funded service delivery workers in regional Victoria.

Tenure length	Fixed-term rental agreements of up to three years to provide security of tenure.
