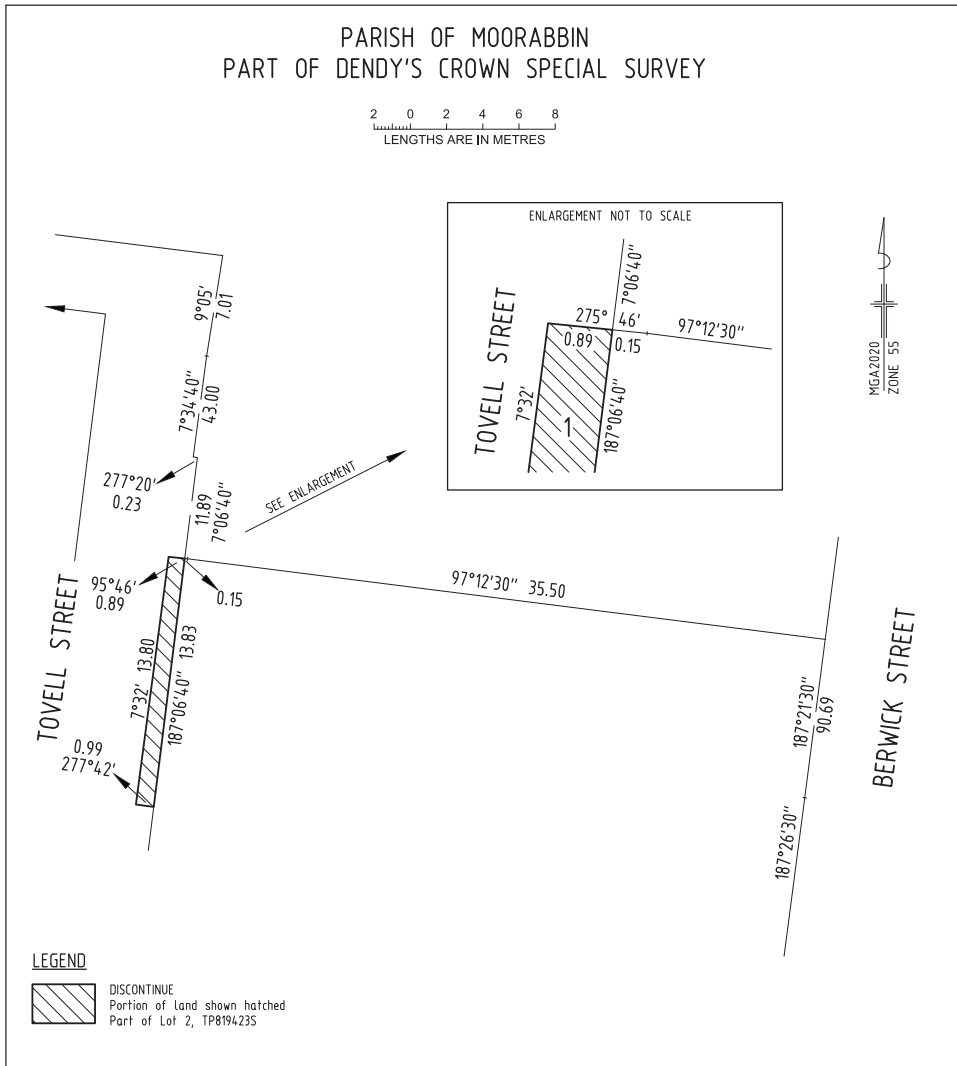

## EXEMPTION

Application No. H319/2022

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Women's Health in the North Inc (the applicant). The applicant amended its initial application and now seeks an exemption to enable the applicant to:

- advertise for and employ women and gender diverse people only to work at the Women's Health in the North Inc;
- advertise for and employ women and gender diverse people only of a specified race or ethnic origin, or whose first language is a specified language other than English, to work in the organisation on specific projects targeted at groups of women and gender diverse people of that race or ethnic origin, or whose first language is that language;

- restrict individual membership of the organisation to women and gender diverse people only; and

- require that organisations that are members of the Women's Health in the North Inc be represented at meetings (whether they are present to attend, speak or vote) by women and gender diverse people only.

'Women and gender diverse people' includes people who identify as women and people whose gender identity does not align with the gender assigned at birth. 'Gender diverse' is inclusive of trans, non-binary, agender, intersex and other gender diverse individuals. 'Women and gender diverse people' does not include individuals for whom their biological sex and gender identity is male (the exempt conduct).

On direction from the Tribunal, the applicant notified its employees and relevant unions about the application, publicised the application on its website, invited submissions for or against the application to be sent to the Tribunal, and invited attendance at the hearing held on 24 January 2023.

Upon reading the material filed in relation to this application, including the written submissions and the oral evidence of Helen Riseborough, Chief Executive Officer, the affidavit and oral evidence of Susan Rosenhain, Manager Strategic Partnerships and Health Policy, and the written submissions received in support of the application from Tilly Mahoney and Amelia Arnold, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal notes:

- The applicant is a community health promotion organisation funded through the Victorian Government's Women's Health Program. The organisation works in partnership with other health and community agencies in the northern metropolitan region of Melbourne to eliminate gender inequalities and improve the health, safety and wellbeing of women and gender diverse people.
- The applicant delivers community and professional education and training,



undertakes advocacy and research projects, disseminates information, and provides programs for specific groups and needs in the community. The applicant's current activities include programs addressing financial literacy, COVID-19 health and immunisation, gendered violence, family violence, sexual and reproductive health, gender equity, health, safety and the well-being of women and gender diverse people.

- The applicant currently employs 33 staff. As a small organisation, all employees are required to play an active and visible role in community events and campaigns focussed on the health and rights of women and gender diverse people. All employees assist with programs and activities, responding to requests for information and referrals, and liaise with other health and community organisations in the region.
- The Victorian Equal Opportunity and Human Rights Commission was notified of the application and did not seek leave to intervene.
- Given the size of the organisation, the specific groups and needs of some of its clients, and the requirements of all staff to respond to requests for information and referrals, the Tribunal accepts the applicant's submissions that it is preferable that only women and gender diverse people work in the organisation, and that its membership benefits and services be limited to women and gender diverse people only. The Tribunal accepts that some of the specific projects targeted at specific races or ethnic origins or specified language groups do not come within section 88 or section 12 exemptions due to their broader audience or training aims. The Tribunal accepts the applicant's submission that these programs are more effective when staffed by women and gender diverse people of the targeted specified race or ethnic origin or language group. No exception or exemption in the Act applies to the exempt conduct.
- The applicant was granted an exemption for similar conduct in 2009, 2012 and 2017. In the absence of a further exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). The Tribunal considered the nature of the right, the importance of the purpose of the limitation, the nature and extent of the limitation, and the relationship between the limitation and its purpose, and any less restrictive means reasonably available to achieve the purpose the limitation seeks to achieve. This exemption limits the right to equality and, in particular, the right to equal and effective protection against discrimination of people who do not identify as women or gender diverse people, or people who do not identify as women or gender diverse people from a particular race or ethnic origin, who wish to be employed by the applicant, or who wish to receive membership benefits and services. Information and research referred to in the submissions in support of the application support the applicant's submissions that women and gender diverse people continue to experience high rates of intimate partner violence, gendered violence, family violence, sexual violence and coercion. The Tribunal accepts the importance of providing a safe, confidential, and respectful environment where women and gender diverse people seeking health information, advice, referral, or training, feel comfortable and able to disclose personal and sensitive health and wellbeing information. The Tribunal accepts the applicant's submissions that their clients expect to be assisted by women and gender diverse people when contacting a community health organisation focussed on improving the health, safety and well-being of women and gender diverse people. The Tribunal accepts that having women and gender diverse people in all employment roles, and as members of the organisation, enables the organisation to provide its services and achieve better health, safety and well-being outcomes for women and gender diverse people. The Tribunal considers the exempt conduct is focussed and directed to deliver this, and accepts there is no less restrictive means reasonably available to

the applicant to achieve this. The Tribunal notes the exemption will not adversely affect anyone seeking employment or membership services from other organisations.

- On the evidence before the Tribunal, taking into account all relevant factors, the Tribunal is satisfied that the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 16 February 2028.

**1. Title**

This Notice may be cited as the Fisheries (Recreational Abalone Open Days) Notice 2023.

**2. Objective**

The objective of this Notice is to specify open days when recreational fishing for abalone is permitted in central Victorian waters.

**3. Authorising provision**

- (ii) all marine waters between longitude 145° 53' 35" East and longitude 145° 53' 53" East, to the north or north-east of a line running from the point 38° 50' 21" South, 145° 53' 39" East (northern part of Arch Rock), to the point 38° 50' 18" South, 145° 53' 50" East, on the mainland.

**Port Phillip Bay** means all the waters within the bays lying north of a line from the most seaward point of Point Lonsdale to the most seaward point of Point Nepean and includes the waters of Hobsons Bay and Corio Bay, but not the waters of Swan Bay.

**6. Permitted Recreational Abalone Fishing Days in central Victorian waters (excluding Port Phillip Bay)**

This Notice prevails over the abalone closed season specified in the table in regulation 294 of the Fisheries Regulations 2019 and permits recreational abalone fishing in central Victorian waters on the following days:

- every Saturday and Sunday between 16 November 2022 and 30 April 2023, inclusive;
- every Declared Public Holiday in the State of Victoria between 16 November 2022 and 30 April 2023, inclusive;
- 25 December 2022 through to the second Sunday in January 2023, inclusive.

**Plant Biosecurity Act 2010****ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION INTO VICTORIA OF MATERIALS WHICH ARE HOSTS OF ONION SMUT**

I, Rosa Crnov, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic disease onion smut exists within Australia but outside Victoria, make the following Order.

**1 Objective**

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of materials which are hosts of onion smut.

**2 Authorising provision**

This Order is made under section 36(1) of the **Plant Biosecurity Act 2010** (the Act).

**3 Commencement**

This Order comes into force on 10 February 2023.

**4 Revocation**

The Order entitled Order prohibiting or restricting the entry or importation into Victoria of materials which are hosts of onion smut made under section 36(1) of the **Plant Biosecurity Act 2010** and published in Victoria Government Gazette G7 on 17 February 2022 at pages 679–680 is revoked.

**5 Definitions**

In this Order –

**host material** means any agricultural equipment used in growing, harvesting, processing or transport of any plant of the genus *Allium*; and any packaging which has contained any plant of the genus *Allium*.

**onion smut** means the exotic disease caused by the fungus *Urocystis cepulae* (Frost).

**6 Prohibitions, restrictions and conditions**

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of host material.

- (a) The entry or importation into Victoria of any host material is prohibited.
- (b) Sub-clause (a) does not apply if the host material –
  - (i) originates from an area for which there is currently in force an area freedom certificate issued by an officer responsible for agriculture in the State or Territory from which the material originated, certifying that the area from which the material originated is known to be free of onion smut; or
  - (ii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the material has been treated in a manner described in the Schedule to this Order; or
  - (iii) enters Victoria under and in accordance with a permit issued by an inspector and there is compliance with any conditions or requirements set out in the permit.

**7 Verification of Consignments**

Where requested by an inspector, host material imported into Victoria which is required by Clause 6(b)(ii) to be accompanied by a certificate or declaration must be presented to an inspector for inspection.

**8 Expiry**

This Order remains in force for a period of 12 months from the date of making.

**Schedule**

Host material must be –

- (1) cleaned free of earth material and organic matter by –
  - (a) high pressure water; or
  - (b) steam; and
- (2) disinfected with a solution containing not less than 100 ppm available chlorine, used as a spray rinse and allowed to dry without rinsing.

EXEMPTION

Occupational Health and Safety Regulations 2017  
Exemption Number D19/7322/12

1. I, Narelle Beer, acting under regulation 538 of the Occupational Health and Safety Regulations 2017 (Regulations) and any and all other enabling powers hereby:
  - (a) revoke the exemption issued as H17/00702 and published in Special Edition No. S 276 of the Government Gazette on 17 August 2017; and
  - (b) exempt the employers listed in Item 5 of this Exemption (**Listed Employers**) from the requirement in regulation 129 of the Regulations that an employer must not allow unlicensed employees to perform any high risk work, subject to the remainder of this Exemption.

**Application of exemption**

2. This Exemption only applies in relation to Lineworkers who would otherwise be required to hold a Basic, Intermediate or Advanced Rigging Licence, for the type of work listed in Item 6 of this Exemption, and subject to the conditions described in Item 7 of this Exemption.
3. I am satisfied that the type of work described in Item 6 of this Exemption can be performed as safely by a person who does not hold a Basic, Intermediate or Advanced Rigging Licence as it could be performed by a person who holds such a licence, provided that the Listed Employers and Lineworkers comply with the conditions imposed in this Exemption.

**Term of exemption**

4. This Exemption will come into effect on 18 February 2023 and will expire at midnight on 18 February 2028, unless it is otherwise revoked or varied by WorkSafe.

**Listed Employers**

5. This Exemption applies to the employers listed in the following table:

**Type of work**

6. This Exemption is restricted to Lineworkers undertaking rigging work that requires a High Risk Work Licence, when undertaking rigging activities associated with the use of mechanical loadshifting equipment and associated gear for:
- (a) movement of plant and equipment where that plant and equipment is being used for the erection or maintenance of a powerline; but not a powerline associated with a tower;
  - (b) erecting and removing distribution pole type substations;
  - (c) pole erection into, or removal from, conductors whether the line be live or isolated;
  - (d) installation, straining, removal and maintenance of overhead conductors and cables;
  - (e) steel erection and removal where the steel components are prefabricated cross arms, brackets, braces, equipment and platforms fitted to a distribution powerline structure;
  - (f) erection, installation and removal of electrical plant and equipment;
  - (g) crossarm installation, removal or replacement; and
  - (h) erecting, dismantling and maintaining stays and guys for distribution electrical structures.

**Conditions**

7. This Exemption is subject to the following conditions, failure to comply with these conditions may result in WorkSafe exercising its power to vary or revoke an exemption under regulation 550:
- (a) Lineworkers performing dogging work must hold:
    - (i) a dogging licence as described in item 4 of Schedule 3 to the Regulations; or
    - (ii) a high risk work licence issued by an interstate authority that is recognised as equivalent to a dogging licence issued under the Regulations, in accordance with regulation 131.
  - (b) A Lineworker covered by this Exemption must be:
    - (i) an apprentice working under appropriate supervision; or
    - (ii) a qualified Distribution Lineworker or Transmission Lineworker who has been trained and undergone written and practical assessment, and is deemed to be competent to all of the following national competency standards by a Registered Training Organisation whose scope of registration includes these matters:
      - i. UETDRIS008 – Install and maintain electrical apparatus;
      - ii. UETDRIS012 – Install and maintain poles, structures and hardware; and
      - iii. UETRIS007 – Install and maintain distribution overhead conductors and cables; or
    - (iii) hold an equivalent historical qualification/certificate of proficiency as a Distribution Lineworker or a Transmission Lineworker.
  - (c) Satisfactory completion of the three training units UETDRIS008, UETDRIS012 and UETDRIS007, or verification of an equivalent historical qualification/certificate of proficiency must be clearly recorded in either the Lineworker's Electrical Supply Industry (ESI) Worker Program or other readily identified means. If a Lineworker has not completed the three training units referred to in this Item and is unable to provide verification of an equivalent historical qualification/certificate of proficiency, they must provide documentary evidence of that historical qualification/certificate of proficiency, for example by way of a statutory declaration identifying the historical qualification/certificate of proficiency and when it was obtained. The Lineworker must have access to the ESI Worker Program at all times while working under this Exemption. Access to the ESI Worker Program shall be readily available to WorkSafe upon request.

- (d) Each Lineworker who, at the time of this exemption coming into effect, meets the requirements of Condition 7(b)(ii) or 7(b)(iii) must be re-assessed. Re-assessments for each of the categories of Lineworker (apprentice, intermediate and experienced), are to be carried out within 18 months of this exemption coming into effect.
- (e) The Listed Employers must provide each Lineworker working under this Exemption with a copy of the document ‘VESI Fieldworkers Handbook June 2006, updated November 2008’.
- (f) Training material or any applicable module must be reviewed and/or amended after any serious incident or where a near miss occurs which may affect the training in that module.
- (g) The training and assessment records referred to in Items 7(b), 7(c) and 7(d) of this Exemption must be:
- (i) retained by the Listed Employers or the contractors or subcontractors engaged to perform work for a Listed Employer/s; and
  - (ii) readily available to WorkSafe, which will conduct audits of these records from time to time at its discretion to ensure that the conditions in this Exemption Notice are observed.
- (h) A validation document must be submitted to WorkSafe by VESI (or nominated representative), relevant to the training and assessment material developed for the purpose of this Exemption, indicating it is relevant to the Units of Competency for:
- (i) Licence to perform rigging basic (RB);
  - (ii) Licence to perform rigging intermediate (RI);
  - (iii) Licence to perform rigging advance (RA) and
- Assessments are applied in accordance with the requirements for assessment, as under the current High Risk Work Licence Assessment system.
- The validation document is required to be submitted to the Authority within six (6) months of commencement of this Exemption.
- During this six (6) month process, regular meetings will be held between WorkSafe and the Listed Employers (or the nominated representative) to ensure that validation documents are in accordance with the requirements of assessment under the current High Risk Work Licence Assessment system.
- (i) Whenever assessment and re-assessment activities for each of the categories of Lineworker (apprentice, intermediate and experienced) are to be carried out, the Listed Employers must submit a timetable advising seven (7) days prior to the commencement of the assessment and re-assessment activities detailing the date and place they are to be undertaken to enable auditing by WorkSafe. An auditing program will include at a minimum two (2) desktop audits and two (2) on-site observation of the Listed Employers assessment per calendar year.
- (j) Each Listed Employer undertakes to:
- (i) cooperate with WorkSafe to readily enable the audit of the rigging assessment processes within the above training units delivered by a Registered Training Organisation; and
  - (ii) advise WorkSafe of any legal entity name and/or ACN changes within seven (7) days of such change occurring.

**Definitions**

8. Unless otherwise indicated, all terms have the same meaning as in the **Occupational Health and Safety Act 2004** or the Regulations.

**Assessment** means the first assessment a Lineworker/Linesman has completed in order to meet the requirements of Condition 7(b)(ii).

**Apprentice Lineworker** means a Lineworker/Linesman undertaking an apprenticeship who is in the first two years of their apprenticeship.

**Distribution Lineworker** means a Lineworker/Linesman engaged in working on distribution and sub transmission assets up to and including 66kV.

**Experienced Lineworker** means a Lineworker/Linesman who is trade qualified with more than five years' work experience in ESI, or holds a HRW Rigging Licence (Basic or Intermediate).

**Intermediate Lineworker** means a Lineworker/Linesman who is either:

- (a) an apprentice in their third or fourth year of their apprenticeship; or
- (b) a Trade Qualified Lineworker with less than three years' work experience in the Electrical Services Industry; or
- (c) a Trade Qualified Lineworker with between three and five years' work experience in the Electrical Services Industry.

**Lineworker** means a Distribution Lineworker/Linesman or a Transmission Lineworker/Linesman who:

- (a) has met the qualification requirements detailed under the condition described in Item 7(b) of this Exemption; and
- (b) is either:
  - (i) an employee of a Listed Employer; or
  - (ii) a contractor or subcontractor engaged to perform work for a Listed Employer; or
  - (iii) an employee of a contractor or subcontractor engaged to perform work for a Listed Employer.

**Listed Employer** means an employer listed in Item 5 of this Exemption.

**Reassessment** means a subsequent assessment.

**Transmission Lineworker** means a Lineworker/Linesman engaged in working on transmission assets above 66kV.

**WorkSafe** means the Victorian WorkCover Authority.

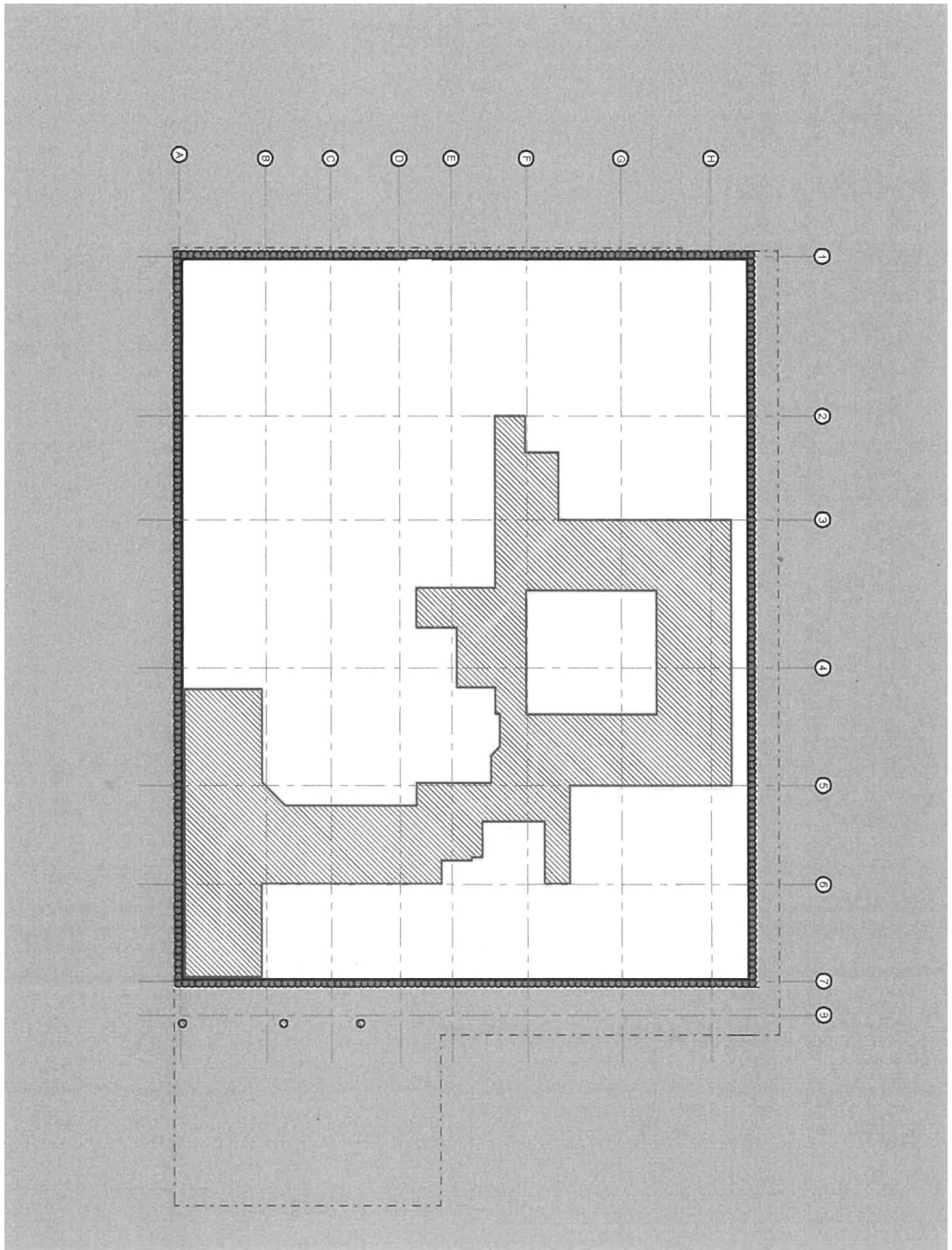

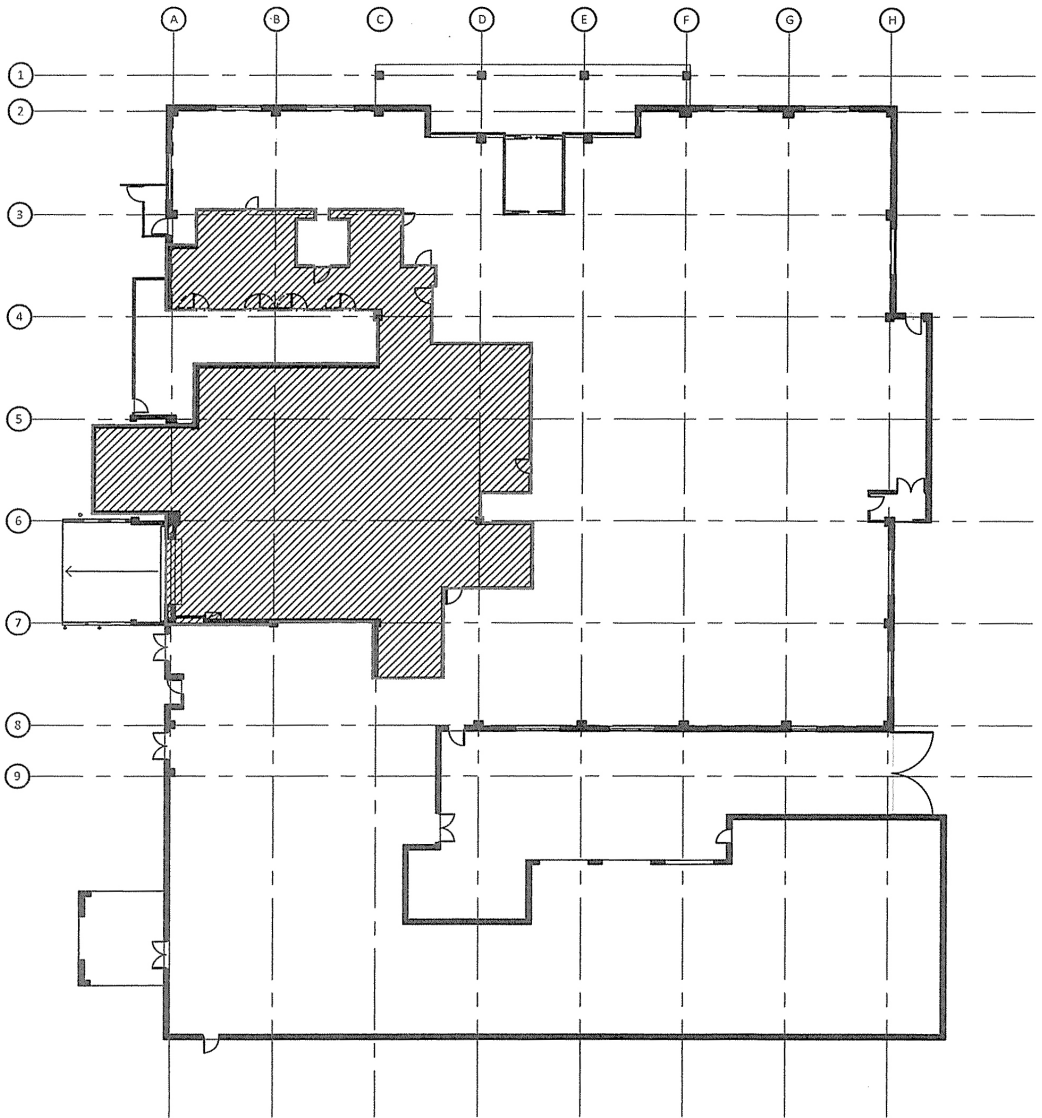

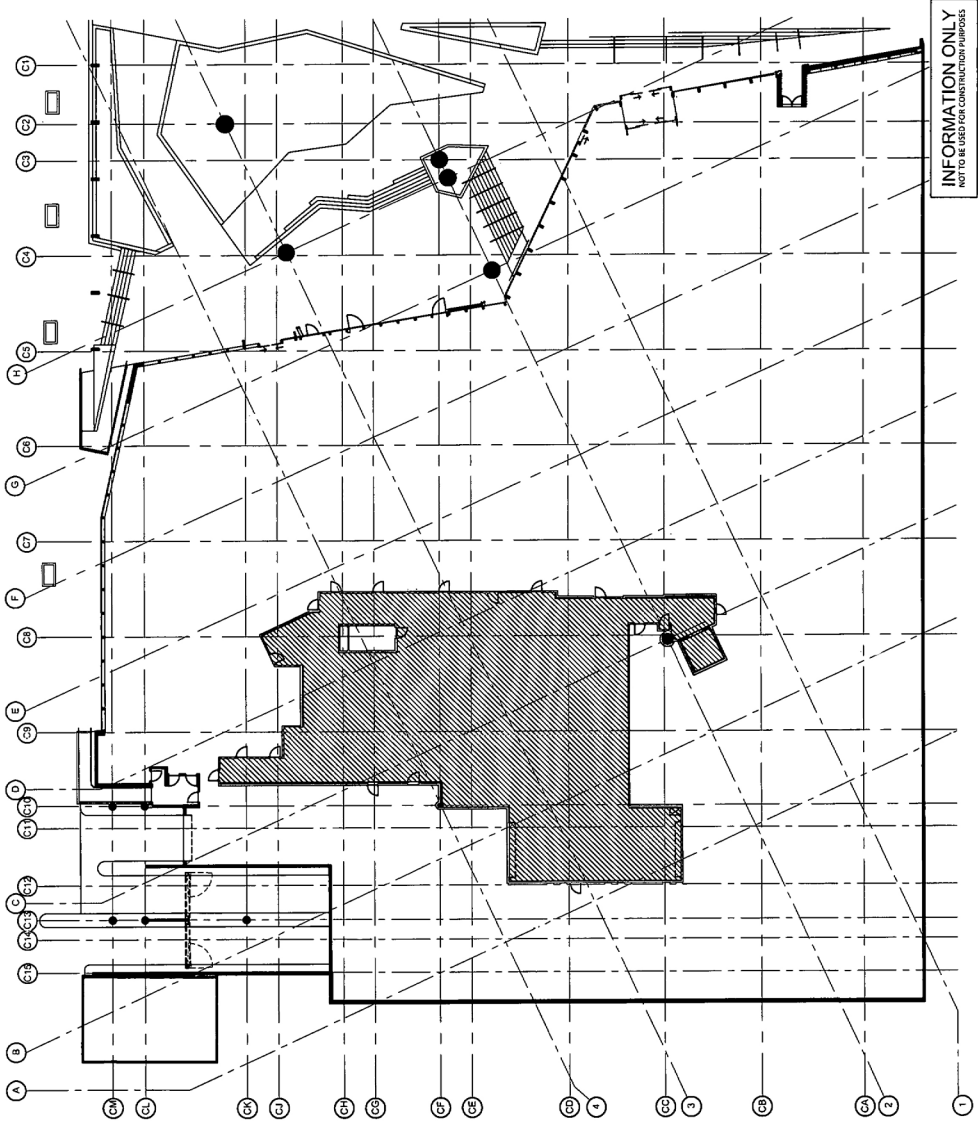
