FISHERIES (EASTERN ABALONE ZONE) NOTICE 2023–2024

1. Title

This Notice may be cited as the Fisheries (Eastern Abalone Zone) Notice 2023–2024.

2. Objectives

The objective of this Notice is to:

- a. fix minimum size limits for blacklip abalone taken under an Abalone Fishery Access Licence in the Eastern Abalone Zone;
- b. address sustainability concerns for Victorian Eastern Abalone Zone abalone stocks and related management issues by closing specified marine waters to commercial abalone harvest.

3. Authorising provision

This Notice is made under sections 67, 68A, 114 and 152 of the Act.

4. Commencement

This Notice comes into operation on 1 April 2023.

5. Definitions

In this Fisheries Notice –

'AFAL' means an Abalone Fishery (Eastern Zone) Access Licence;

'CEO' means the Chief Executive Officer of the VFA;

'closed waters' means -

- (a) any marine waters within a spatial management unit for which the upper limit has been reached or exceeded as specified in Column 3 of Schedule 2; and
- (b) any marine waters within a reef code for which the upper limit has been reached or exceeded as specified in Column 3 of Schedule 3;

'eastern abalone zone' means all Victorian marine waters east of longitude 148° East;

'nominated operator' means -

- (a) a licence holder permitted under section 39(1) of the Act; or
- (b) a person listed on an access licence for the purposes of section 39(2) of the Act;

'size zone' means each area of Victorian marine waters between the coordinates specified in Column 2 of Schedule 1;

'spatial management unit' means each area of Victorian marine waters specified in Column 1 of Schedule 2;

'reef code' means each area of Victorian marine waters specified in Column 1 of Schedule 3;

'the Act' means the Fisheries Act 1995;

'upper limit' means –

(a) for any spatial management unit specified in Column 1 of Schedule 2, the corresponding amount of abalone specified in Column 3 of Schedule 2; and

(b) for any reef code specified in Column 1 of Schedule 3 means the corresponding amount of abalone specified in Column 3 of Schedule 3;

'VFA' means the Victorian Fisheries Authority.

6. Minimum sizes for blacklip abalone taken from the eastern abalone zone

(1) For the purposes of the Act, the minimum size with respect to the taking of blacklip abalone under an AFAL from the waters specified in Column 1 of Schedule 1 is the size specified for those waters in Column 3 of Schedule 1.

Notes: There are offences in sections 68A and 68B of the Act relating to taking or possessing fish of a species that are less than the minimum size specified for that species of fish in this Notice. Various penalties apply. Under section 152(3) of the Act, if a provision of this Notice is inconsistent with any regulations, the Fisheries Notice prevails to the extent of the inconsistency. The general size limits specified in the Fisheries Regulations 2019 will continue to apply in circumstances where the size limits specified in clause 6 does not apply.

7. Abalone not to be taken from more than one size zone

For the purposes of section 67 of the Act –

- (a) the taking of abalone under an AFAL from more than one size zone on any fishing trip; or
- (b) the possession of abalone taken from more than one size zone on-board any boat being used under an AFAL; or
- (c) the landing of abalone taken under an AFAL from more than one size zone; is prohibited.

Note: It is an offence under section 67(3) of the Act to fail to comply with a prohibition.

8. Spatial management unit catch upper limit target exceeded

Marine waters within a spatial management unit are immediately closed ('closed waters') to commercial abalone harvest when the upper limit specified in Column 3 of Schedule 2 has been reached or exceeded.

9. Reef code upper limit catch exceeded

Marine waters within a reef code are immediately closed ('closed waters') to commercial abalone harvest when the upper limit specified in Column 3 of Schedule 3 has been reached or exceeded.

10. Closed waters

- (1) For the purposes of section 67 of the Act
 - (a) the taking of abalone from closed waters; or
 - (b) the possession of abalone in or on closed waters –

by the holder of an access licence, or a person acting or purporting to act under an access licence, is prohibited.

(2) Sub-clause (1)(b) does not apply to a person possessing abalone on-board a boat under way and travelling by the most direct route to reach a point of landing or specified open waters for the purpose of commercial abalone diving.

Note: Failure to comply with this prohibition is an offence under section 67 of the Act. A maximum penalty of 100 penalty units and/or six months imprisonment applies.

11. Application to fisheries reserves

This Notice applies to a Fisheries Reserve, as declared under section 88 of the Act, to the extent that fishing is permitted in the Fisheries Reserve.

12. Revocation

(1) Unless sooner revoked, this Notice will be revoked on 31 March 2024.

I, Travis Dowling, Chief Executive Officer, Victorian Fisheries Authority, as delegate of the Minister for Outdoor Recreation, having undertaken consultation in accordance with section 3A of the **Fisheries Act 1995** (the Act), make the following Quota Order under section 64A of the Act for the Pipi Fishery.

- 1. This Order applies for the period commencing 1 April 2023 and ending on 31 March 2024 both dates inclusive (the quota period).
- 2. The total allowable catch for Discovery Bay (Western) pipi zone is 10,000 kg.
- 3. The total allowable catch for Discovery Bay (Eastern) pipi zone is 40,000 kg.
- 4. The total allowable catch for Venus Bay commercial pipi zone is 2,000 kg.
- 5. Individual quota units have been calculated based on a total quota of 52,000 kg with a maximum of 1,000 quota units, with each quota unit equating to 52 kg.

This Order commences on 1 April 2023 and remains in force until the end of 31 March 2024.

FISHERIES (OCEAN SCALLOP) NOTICE 2023

1. Title

This Notice may be cited as the Fisheries (Ocean Scallop) Notice 2023.

2. Objectives

The objective of this Notice is to establish a temporary prohibition on the use and possession of commercial fishing equipment by holders of a Scallop (Ocean) Fishery Access Licence in specified scallop waters.

3. Authorising provision

This Notice is made under sections 114 and 152 of the Act.

4. Commencement

This Notice comes into operation on 1 April 2023.

5. Definitions

In this Fisheries Notice -

'specified scallop waters' means the marine waters enclosed by the line:

- (a) commencing at the point of latitude 38° 24.000′ South, longitude 147° 30.000′ East;
- (b) from there running generally east to the point of latitude 38° 24.000' South, longitude 147° 36.000' East;
- (c) from there running generally south to the point of latitude 38° 30.000' South, longitude 147° 36.000' East;

- (d) from there running generally west to the point of latitude 38° 30.000' South, longitude 147° 30.000' East;
- (e) from there running generally north to the point of commencement at latitude 38° 24.000' South, longitude 147° 30.000' East.

And the line:

- (f) commencing at the point of latitude 38° 49.859' South, longitude 146°50.080' East;
- (g) from there running generally south to the point of latitude 38° 50.290' South, longitude 146° 50.219' East;
- (h) from there running generally west to the point of latitude 38° 50.839' South, longitude 146° 48.700' East;
- (i) from there running generally North to the point of latitude 38° 49.847' South, longitude 146° 48.790' East;
- (j) from there running generally East to the point of commencement at latitude 38° 49.859' South, longitude 146°50.080' East.

6. Prohibition on the use of commercial fishing equipment in specified scallop waters

For the purposes of section 114 of the Act, the use of commercial fishing equipment by the holder of a Scallop (Ocean) Fishery Access Licence, or a person acting or purporting to act under the licence, in specified scallop waters is prohibited.

7. Prohibition on the possession of commercial fishing equipment in specified scallop waters

- (1) For the purposes of section 114 of the Act, the possession of commercial fishing equipment by the holder of a Scallop (Ocean) Fishery Access Licence, or a person acting or purporting to act under the licence, in specified scallop waters is prohibited.
- (2) Sub-clause (1) does not apply to the holder of a Scallop (Ocean) Fishery Access Licence, or a person acting or purporting to act under the licence, who possesses commercial scallop fishing equipment on-board a boat under way and travelling by the most direct route through specified scallop waters to reach a point of landing or marine waters for the purpose of commercial scallop fishing.

8. Application to Fisheries Reserves

For the purposes of section 152(4), this notice applies to all Fisheries Reserves.

9. Revocation

Unless sooner revoked, this Notice will be revoked on 31 March 2024.

Notes:

Contravention of any prohibition under section 114 of the Act, as set out in this Fisheries Notice, is an offence under section 114(3) of the Act. A maximum penalty of 100 penalty units or 6 months imprisonment (or both) applies. For the purposes of this Fisheries Notice, a reference to the longitude or latitude of a geographical point is based on

WGS84 geodetic datum.

2. Objectives

ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION INTO VICTORIA OF MATERIALS WHICH ARE HOSTS OF POLYPHAGOUS SHOT-HOLE BORER

I, Rosa Crnov, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic pest polyphagous shot-hole borer exists within Australia but outside Victoria, make the following Order.

1 Objective

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of materials which are hosts of polyphagous shot-hole borer.

2 Authorising provision

This Order is made under section 36(1) of the Plant Biosecurity Act 2010.

3 Commencement

This Order comes into force on the date it is signed and remains in force for a period of 12 months unless revoked earlier.

4 Definitions

In this Order –

agricultural equipment means any vehicle, equipment or other mechanical apparatus of any kind that has been used in relation to host plants and timber.

host material means any host plant, timber and agricultural equipment.

host plant means any plant described on the Western Australian government website (www.agric.wa.gov.au/borer) with woody stems or branches that are greater than 2.0 cm in diameter.

polyphagous shot-hole borer means the exotic pest Euwallacea fornicatus (Eichhoff).

seasoned timber means timber or wood including construction and fencing materials, and furniture that has been -

- dried, or
- treated to a hazard class of H2 or greater as provided in the AS/NZS 1604 series 'Specification for preservative treatment'.

timber means wood (round or sawn, with or without bark) of any host plant including firewood and woodchips where the chips are greater than 2.5 cm, excepting seasoned timber.

5 **Prohibitions, restrictions and conditions**

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of host material.

(a) The entry or importation into Victoria of any host material is prohibited.

- (b) Sub-clause (a) does not apply if the polyphagous shot-hole borer host material
 - (i) originates from an area for which there is currently in force an area freedom certificate, being a certificate issued by an officer responsible for agriculture in the State or Territory from which the host material originated, certifying that the area from which the host material originated is known to be free of polyphagous shot-hole borer; or
 - (ii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the material has been treated in a manner prescribed in the Schedule to this Order and where a copy of the certificate or declaration is forwarded to Agriculture Victoria at market.access@agriculture.vic.gov.au prior to despatch of the material; or
 - (iii) enters Victoria under and in accordance with a permit issued by an inspector and there is compliance with any conditions or requirements set out in the permit.

6 Verification of Consignments

Where requested by an inspector, host material imported into Victoria which is required by clause 5(b)(ii) to be accompanied by a certificate or declaration, must be –

- (a) presented to an Inspector for inspection; or
- (b) verified by a person accredited to do so by the Department of Energy, Environment and Climate Action.

Host material -

- (1) in the case of host plants, must
 - (a) be inspected at a rate of 2% or 600-units (whichever is greater) and found to be free of any signs or symptoms of polyphagous shot-hole borer infestation, and be consigned to Victoria within seven days of inspection; or
 - (b) be inspected at a rate of 2% or 600-units (whichever is greater) and found to be free of signs or symptoms of polyphagous shot-hole borer infestation and treated by cover spraying with bifenthrin in accordance with the approved APVMA label or permit for the control of polyphagous shot-hole borer every four weeks; and
- (2) in the case of timber, must -
 - (a) be inspected at a rate of 2% or 600-units (whichever is greater) and found to be free of any signs or symptoms of polyphagous shot-hole borer infestation, and be consigned to Victoria within seven days of inspection; or
 - (b) be treated by
 - (i) fumigation with methyl bromide at a rate of
 - (A) 10°C–15.9°C @ 64 g/m³ for 24 hours; or
 - (B) $16^{\circ}C-20.9^{\circ}C$ (*a*) 56 g/m³ for 24 hours; or
 - (C) 21°C–31.9°C @ 48 g/m³ for 24 hours; and
 - (D) where monitoring at regular intervals throughout the fumigation treatment to ensure minimum concentration is maintained at the following rates; or

Starting temperature and dosage			Minimum concentration (g/m ³) at:		
Temperature	Dosage (g/m ³)	2 h	4 h	12 h	24 h
10°C–15.9°C	64	48	42	36	32
16°C–20.9°C	56	42	36	32	28

- (ii) heat treatment, where the temperature of the core of the timber is measured at a minimum of 56°C for at least 30 minutes.
- (3) in the case of agricultural equipment, must
 - (a) be cleaned free of host material by
 - (i) brushing; or
 - (ii) high pressure water; or
 - (iii) steam; and
 - (b) be inspected and found free of host material and polyphagous shot-hole borer.
