

- 4. Providing for the administration of Council's powers and functions.

The general purpose of the proposed local law is to provide for the following matters:

- preliminary provisions;
- administration and enforcement;
- animals and livestock;
- camping;
- building sites;
- use of roads, Council land and public places;
- environmental health and waste;
- vehicles, parking and petrol pumps;
- Lake Hamilton Reserve and water; and
- obstructions, interference and noise.
