Notice of Approval of Amendment  
Amendment C393boro

The Minister for Planning has approved Amendment C393boro to the Boroondara Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment deletes the interim Heritage Overlay HO901 affecting the Mont Iris Estate and Environs Precinct and applies the Heritage Overlay to two individual heritage places and three heritage precincts on an interim basis until 28 April 2024.
