ADVICE IN RELATION TO A NOTICE OF INTENTION TO REQUEST A WATERWAY RULE

I, Lisa Faldon, Director Maritime Safety (as delegate of Safe Transport Victoria), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rule for the local Port of Anderson Inlet as submitted by Gippsland Ports Committee of Management Inc. on 15 February 2023 is of a material nature and that Gippsland Ports Committee of Management Inc. has been granted an exemption from complying with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rule under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requires Gippsland Ports Committee of Management Inc. to invite submissions and comments in relation to the proposed requests from the public. An exemption has been provided under section 260(1)(c) of the **Marine Safety Act 2010** as compliance would, in the particular circumstances, be impracticable, unnecessary, or inappropriate.

NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

I, Lisa Faldon, Director Maritime Safety (as delegate of Safe Transport Victoria), hereby give notice under section 208(1) of the **Marine Safety Act 2010** that all persons and vessels not registered to take part in the Club Marine Wakeboard SA Summer Wakeboarding Series Round 2 and 3 are prohibited from entering and remaining in the following waters.

Waters of Ouyen Lake – Entire Lake.

The exclusion zone will be in effect between 8.00 am to 6.00 pm on Saturday 4 March and Sunday 5 March 2023.

NOTICE SPECIFYING AN ACTIVITY EXCLUSION ZONE

I, Lisa Faldon, Director Maritime Safety acting in my capacity as delegate of Safe Transport Victoria, pursuant to section 208 of the **Marine Safety Act 2010**, by this notice prohibit:

- all persons, other than members, officers or personnel of Victoria Police, Victoria State Emergency Service, Victorian Fisheries Authority, Strathbogie Shire Council and Safe Transport Victoria, and
- all vessels, other than those operated by Victoria Police, Victoria State Emergency Service, Victorian Fisheries Authority, Strathbogie Shire Council and Safe Transport Victoria, and vessels expressly authorised by members, officers or personnel of Victoria Police, Victoria State Emergency Service, Victorian Fisheries Authority, Strathbogie Shire Council and Safe Transport Victoria,

from entering, or remaining in, the following State waters:

• Goulburn River, 100 metres upstream and downstream of Chinamans Bridge.

This notice comes into effect at 12.00 am on 5 March 2023 and remains in effect until 12.00 am on 30 June 2023.
