NOTICE OF WASTE LEVY WAIVER No. 11

I, Ingrid Stitt, Minister for Environment and Minister responsible for administering the **Environment Protection Act 2017** (the Act), give notice of a waiver made under section 146 of the Act of the requirement to pay a waste levy under section 145 of the Act, which is made in accordance with the following terms.

1. Authorising provision

This waiver is made under section 146(1)(a) of the Act.

2. Definitions

- b. **Affected landfills**, for the purposes of section 146(2)(c) of the Act, means any landfill which receives flood waste from an affected area.
- c. **Emergency**, for the purposes of section 146(1)(a) of the Act, means the flood event in Victoria commencing on or around 13 October 2022.
- d. **Flood waste**, for the purposes of section 146(2)(b) of the Act, means any material deposited on property by the emergency, or material damaged by the emergency that is required to be disposed of as part of the recovery from the emergency.

3. Waiver

The waste levy is waived for all flood waste received by affected landfills from the date 3 March 2023 until 2 May 2023.

4. Conditions

Affected landfills must provide information on flood waste as part of their Waste Levy Statements.
