DELEGATION OF DUTY TO GIVE NOTICE UNDER SECTION 134(6) IN ACCORDANCE WITH SECTION 15A

Level Crossing Removal Project

- 1. I, Ben Carroll MP, Minister for Public Transport, as Project Minister for the Car Parks for Commuters Project and the Car Parks for Commuters Project, Stage 2 Level Crossing Removal Project, being declared projects under the **Major Transport Projects Facilitation** Act 2009 (Act) for which designation of the project area for the aforementioned projects has occurred in accordance with Part 4 of the Act, hereby delegate, under section 15A of the Act, the duty to give notice to a Public Authority or Council or person affected by any Order in accordance with section 134(6) of the Act to a person from time to time designated as the Chief Executive Officer of the Level Crossing Removal Project.
- 2. This delegation is subject to the publication of any Order in the Government Gazette under section 134(1) of the Act made by the Governor in Council on the recommendation of the Project Minister.
- 3. This delegation will remain valid until it is revoked.
