ORDER UNDER SECTION 134(1)(b) DIVESTING PUBLIC AUTHORITY OR COUNCIL LAND FOR AN APPROVED PROJECT

Order In Council

The Governor in Council under section 134(1)(b) of the **Major Transport Projects Facilitation Act 2009**, on the recommendation of the Minister for the Suburban Rail Loop, divests the land identified in the Schedule, being land in the project area of the Suburban Rail Loop East from Whitehorse City Council.

In accordance with section 134(3B) of the **Major Transport Projects Facilitation Act 2009**, the land identified in the Schedule is to vest in the project authority.
