AMENDING CONDITIONS NO. 2/2023 DETERMINED UNDER SECTION 220D(1)

The Head, Transport for Victoria, the entity established under section 64A of the **Transport Integration Act 2010** hereby determines, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, the following conditions (the Amending Conditions No. 2/2023) which amend the Conditions under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983** published in the Government Gazette No. S 731 Tuesday 21 December 2021, as amended by amending conditions published in the Government Gazette Nos. S 362 Friday 15 July 2022, S 428 Friday 26 August 2022, S 617 Monday 31 October 2022 and S 143 Monday 27 March 2023.

The Amending Conditions No. 2/2023 take effect on 31 March 2023 immediately after Amending Conditions No. 1/2023, published in the Government Gazette No. S 143 Monday 27 March 2023, take effect.
