1 Objectives

The objective of these Regulations is to amend the expiry date of the Crown Land (Reserves) (Albert Park Reserve and Albert Reserve) Regulations 2008.

2 Authorising provision

These Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

3 Commencement

These Regulations come into operation on the day on which they are published in the Government Gazette.

4 Principal Regulations

In these Regulations, the Crown Land (Reserves) (Albert Park Reserve and Albert Reserve) Regulations 2008 that were published in Special Government Gazette No. S 333 on 3 December 2008, and subsequently amended by the Crown Land (Reserves) (Albert Park Reserve and Albert Reserve) Amendment Regulations 2017 published in Special Government Gazette No. S 458 on 22 December 2017, the Crown Land (Reserves) (Albert Park Reserve and Albert Reserve) Amendment Regulations 2018 published in Government Gazette No. G 34 on 23 August 2018, pages 1832 to 1833, and the Crown Land (Reserves) (Albert Park Reserve and Albert Reserve) Amendment Regulations 2020 published in Special Government Gazette No. S 628 on 1 December 2020, are called the Principal Regulations.

5 Extension of expiry date

For regulation 5 of the Principal Regulations substitute –

'These Regulations expire on 30 June 2023.'.
