## Road Safety Act 1986

### EXEMPTION FROM SECTION 65A(1) OF THE ROAD SAFETY ACT 1986 FOR PERSONS PARTICIPATING IN A VICTORIAN HEAT OF THE AUSTRALIAN NATIONAL CIRCLE WORK CHAMPIONSHIPS AT THE TATURA RACECOURSE

**1. Purpose**

The purpose of this notice is to exempt persons from section 65A(1) of the **Road Safety Act 1986** while participating in a Victorian heat of the Australian National Circle Work Championships on Saturday 6 August 2011 at the Tatura Racecourse.

**2. Authorising provision**

This notice is made under section 65A(3)(a) of the **Road Safety Act 1986**.

Section 65A(1) of the **Road Safety Act 1986** provides that a person must not drive a motor vehicle in a manner which causes the motor vehicle to undergo loss of traction by one or more of the motor vehicle's wheels. (Penalty: 5 penalty units)

Section 65A(3)(a) of the **Road Safety Act 1986** empowers the Minister to declare, by notice published in the Victoria Government Gazette, that section 65A(1) does not apply to persons while participating in a function or event, or a type of function or event, specified in the declaration and conducted on land specified in the declaration.

**3. Commencement**

This notice comes into operation on the day on which it is published in the Victoria Government Gazette.

**4. Expiry**

This notice expires at midnight on Saturday 6 August 2011.

**5. Declaration**

For the purposes of section 65A(3)(a) of the **Road Safety Act 1986**, I, Michael O'Brien MP, Acting Minister for Roads, declare that section 65A(1) of the **Road Safety Act 1986** does not apply to a person while participating in a heat of the Australian National Circle Work Championships on Saturday 6 August 2011 at the Tatura Racecourse, provided that all safety and other requirements, as determined by the event organiser, are complied with.
