Notice of Approval of Amendment

Amendment GC230

The Minister for Planning has approved Amendment GC230 to 14 planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes 14 planning schemes in Victoria by amending zone schedules to ensure alignment with Amendment VC217. Amendment VC217 implemented planning changes to support the decriminalisation of sex work in Victoria. Amendment VC217 was gazetted on 23 June 2022 and came into operation on 1 December 2023.
