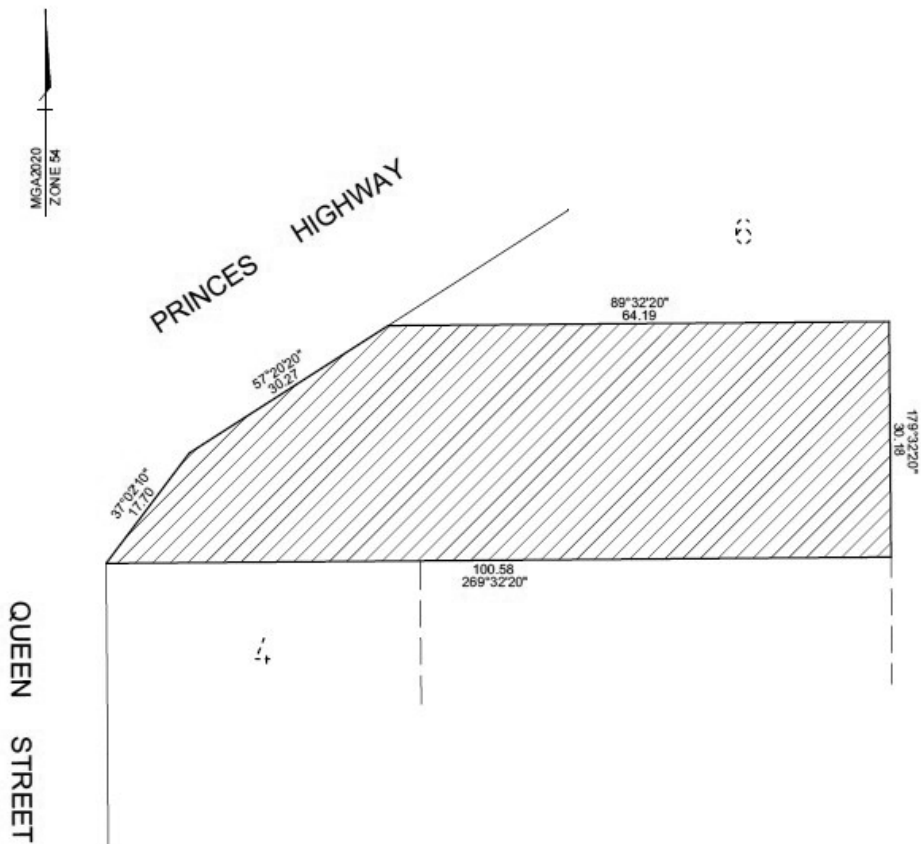



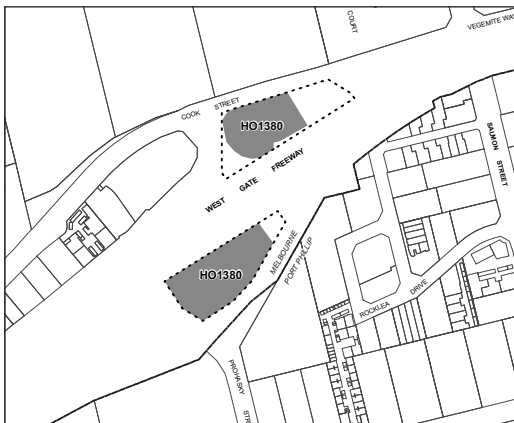


Figure 1: Map showing No. 1 West Gate Freeway (north) and No. 2 West Gate Freeway (south) with the proposed Heritage Overlay extent shaded and the property boundaries shown with a dashed line.

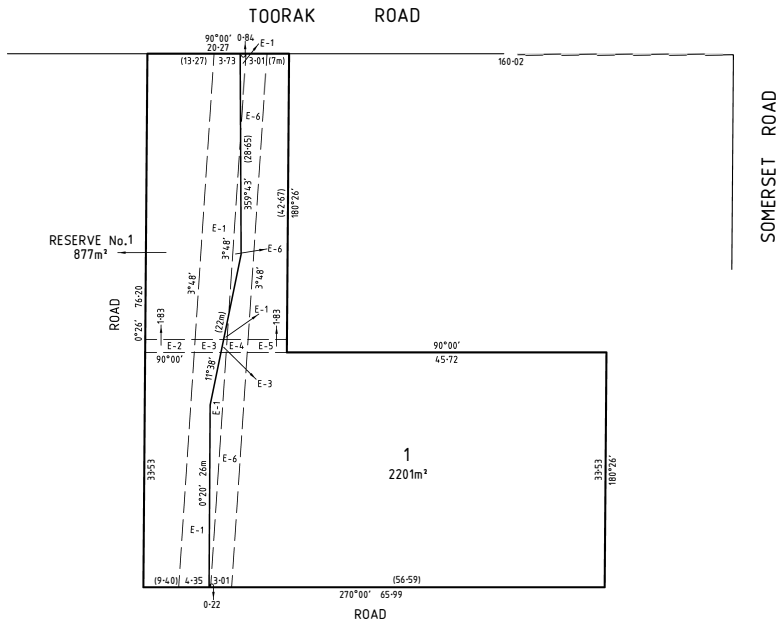

- Masters of rescue vessels are only exempt from items 1 and 2 when undertaking a rescue operation to retrieve persons in distress, provide for their initial medical or other needs and deliver them to a place of safety on shore, and must adhere to speed and distance rules at all other times.
- ‘Trick’ skiers being towed are only exempt from items 3 and 4 provided they wear a bright coloured top. Masters of towing vessels are only exempt from items 1 and 2 for the duration of the events and item 5 when towing water skiers who are participating in trick events, and when retrieving water skiers who are participating in trick events and exempt from wearing a lifejacket.
- All persons on vessels and skiers associated with the event must wear a lifejacket (unless exempt from item 3 or 4 in accordance with these conditions), and vessels must have all prescribed safety equipment, including rescue vessels.
- Should vessels or persons not involved in the event enter the exclusion zone, the event must be stopped until the unauthorised vessel or person has moved outside of the zone.
