COMMITTEE OF MANAGEMENT – INSTRUMENT OF APPOINTMENT

Great Ocean Road Coast and Parks Authority

I, Ruth Caldwell, Regional Director Barwon South West, Regions, Environment, Climate Action and First Peoples Group, Department of Energy, Environment and Climate Action, as delegate of the Minister for Environment, under section 14(2) of the **Crown Land (Reserves) Act 1978** hereby:

- a. revoke all appointments in force under that section with respect to the following reserved Crown land; and
- b. appoint the Great Ocean Road Coast and Parks Authority, as permitted by section 14(4)(d) of the Act, to be the committee of management of the following reserved Crown land, as shown on the numbered plans lodged in the Central Plan Office referred to in the descriptions below:
 - Crown Allotment 2061, Parish of Angahook, as shown on the plan LEGL./21-553;
 - Crown Allotment 19H, Parish of Angahook, as shown on the plan OP126180E;
 - Crown Allotment 15A, Section 2, Township of Anglesea, Parish of Jan Juc, as shown on the plan OP125892.

Note: This Instrument of Appointment amends errors in the Instrument of Appointment made on 13 December 2023 to commence on 1 February 2024 so that the Great Ocean Road Coast and Parks Authority is appointed as the committee of management for the above three allotments from 21 February 2024. The earlier Instrument referred to 'Parish of Jan Juc, Township of Anglesea' in the description of Crown Allotment 2061 instead of 'Parish of Angahook', 'Parish of Angahook' in the description of Crown Allotment 15A instead of 'Parish of Jan Juc' and should also include Section 2 in the description and OP125180E in the description of Crown Allotment 19H instead of OP126180E.

This instrument commences on 21 February 2024.
