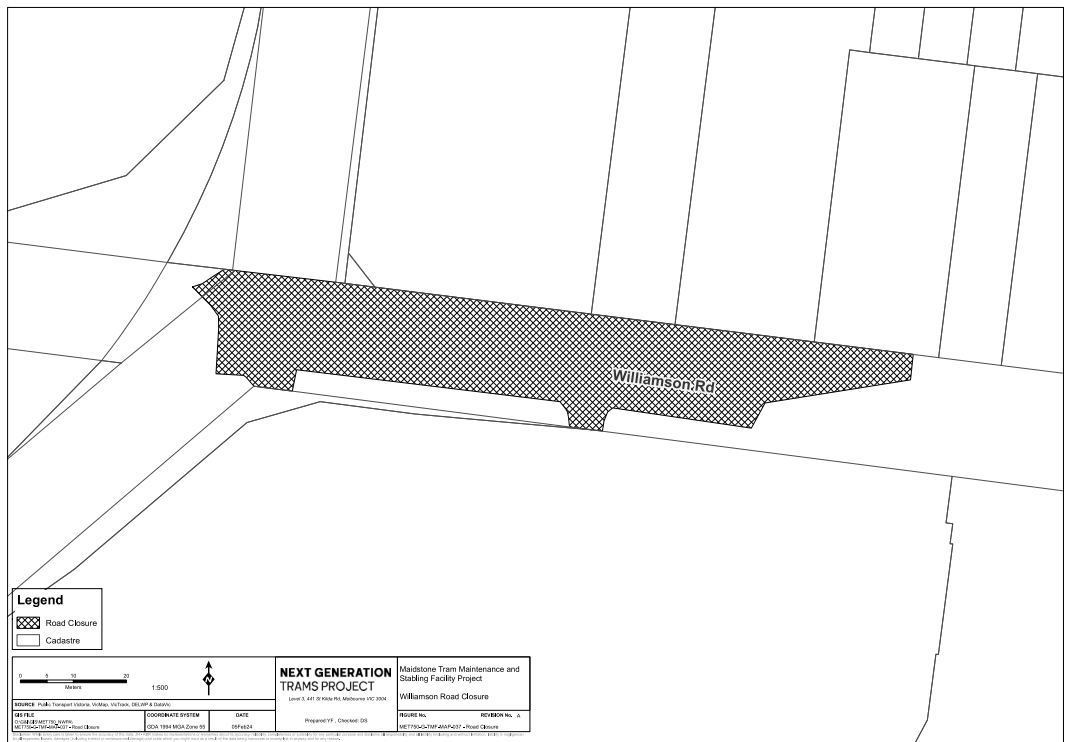

NOTICE OF CLOSURE OF PART OF ROAD TO TRAFFIC

Under section 186D(1)(d) of the **Major Transport Projects Facilitation Act 2009** (Act), I, David Roche, Director, Property Projects, Department of Transport and Planning, as delegate of the project authority for the Maidstone Tram Maintenance and Stabling Facility Project (Project), determine that, for the purposes of the Project, the following part of road shall be closed to traffic:

- Williamson Road, Maribyrnong between part of 28 Williamson Road and the intersection of Hampstead and Williamson Road,
as more particularly shown cross-hatched on the attached plan.



The closure of the part of road identified on the plan shall commence on the later of 29 February 2024 or the publication of this notice.

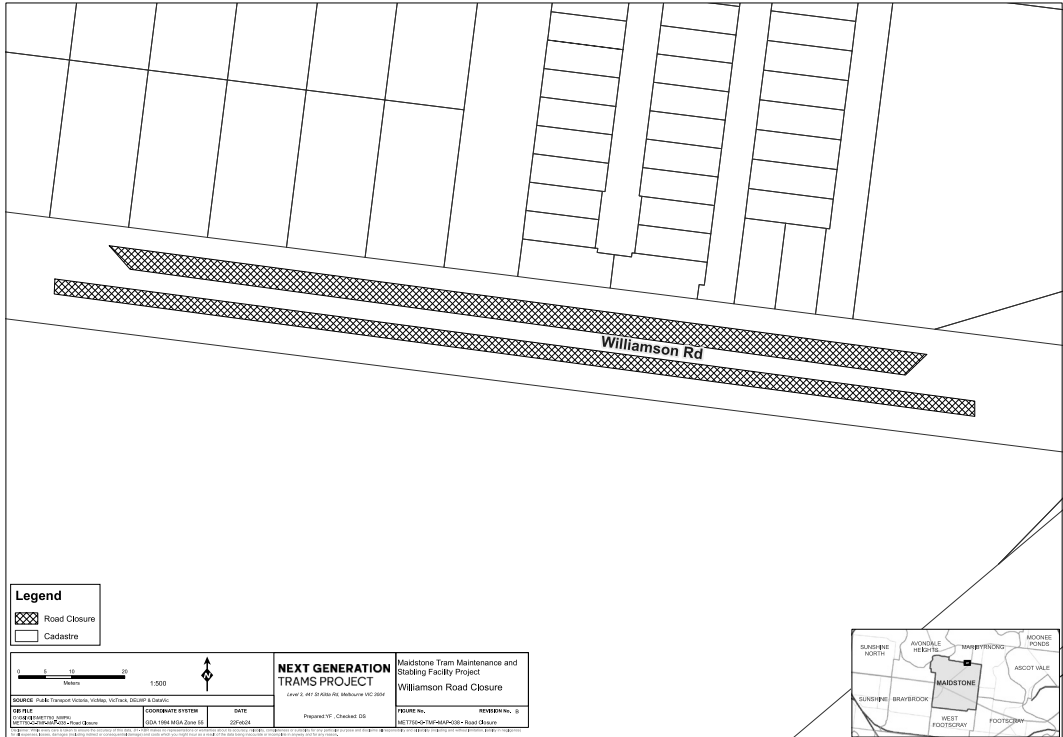
