Gas Industry Act 2001

ORDER UNDER SECTION 40A

I, the Hon. Lily D'Ambrosio, Minister for Energy and Resources and Minister responsible for administering the **Gas Industry Act 2001** (the Act), by Order under section 40A of the Act, having consulted with the Premier, the Treasurer and the Assistant Treasurer as required under section 40C of the Act and having consulted with the affected Licensee as required under section 40D of the Act, specify the following conditions to which the Licensee's licence is subject:

1. The Licensee must not provide, offer or arrange to provide any form of benefit, including (without limitation) any incentive, privilege, inducement, rebate or payment to any person in relation to:
 - a. the establishment of a connection to the Licensee's distribution system by a domestic or small business customer; or
 - b. the installation or replacement of an appliance for a domestic or small business customer, downstream of a gas supply point supplied by the Licensee's distribution system.
2. Clause 1(b) of this Order does not apply in relation to any form of benefit provided, offered or arranged by the Licensee for the repair, service or safety check of an appliance.
3. This Order takes effect 60 calendar days after it is published in the Government Gazette.
4. In this Order:
 - a. '**Licensee**' means AusNet Gas Services Pty Ltd ACN 086 015 036 of Level 31, 2 Southbank Boulevard, Southbank, Victoria 3006;
 - b. '**domestic and small business customer**' means:
 - i. a person who purchases gas principally for personal, household or domestic use; or
 - ii. a person whose aggregate supply of gas has not been, or, in the case of a new gas connection, is not likely to be, more than 1,000 gigajoules in any one year commencing on or after 1 September 2000; and
 - c. '**appliance**' and '**gas supply point**' each have the meaning given to those terms respectively in the **Gas Safety Act 1997**.

 - ii. a person whose aggregate supply of gas has not been, or, in the case of a new gas connection, is not likely to be, more than 1,000 gigajoules in any one year commencing on or after 1 September 2000; and
 - c. **‘appliance’** and **‘gas supply point’** each have the meaning given to those terms respectively in the **Gas Safety Act 1997**.
