## TRANSPORT (COMPLIANCE AND MISCELLANEOUS) (TICKETING) REGULATIONS 2017

Specification of Railway Stations for the Purposes of the Definition of ‘Compulsory Ticket Area’

I, Paul Younis, Secretary to the Department of Transport and Planning, under regulation 5(1) of the Transport (Compliance and Miscellaneous) (Ticketing) Regulations 2017 (the Regulations) specify the railway stations listed in the Schedule to this instrument as railway stations to which paragraph (b) of the definition of ‘compulsory ticket area’ in regulation 5(1) of the Regulations applies.

The *Specification of Railway Stations for the Purposes of the Definition of ‘Compulsory Ticket Area’* published in Government Gazette G 37 dated 13 September 2018, pp 1988–1989 is revoked.

This specification takes effect on and from the date it is published in the Victoria Government Gazette.
