## Dairy Act 2000

### DAIRY FOOD SAFETY VICTORIA DETERMINATION OF LICENCE CLASSES AND FEES FOR DAIRY BUSINESSES

1 July 2024–30 June 2025

- 1) Dairy Food Safety Victoria (DFSV), being the Authority established under section 4 of the **Dairy Act 2000** (the Act) –
  - a. determines the different classes of dairy industry licences specified in Column 1 of Table 1 and Column 1 of Table 2, as provided by section 25(2) of the Act;
  - b. fixes the fees specified in Columns 2, 3, and 4 of Table 1, in respect of licence classes specified in Column 1 as provided by sections 6(f), 7(2)(b), 23(1)(c) and 24(1) of the Act;
  - c. fixes the fees specified in Columns 2, 3, and 4 of Table 2, in respect of licence classes specified in Column 1 as provided by sections 6(f) and 7(2)(b) of the Act.
- 2) In this instrument –

*application fee* means the fee payable to DFSV by the applicant on the making of an initial application of a dairy industry licence under section 23 of the Act;

*licence class* means a class of dairy industry licence as determined by DFSV under section 25(2) of the Act;

*licence fee* means the fee payable to DFSV on the issuing or renewal of a licence by a holder of a licence under section 25 of the Act;

*transfer fee* means the fee payable to DFSV on the transfer of an existing licence to another person or company under section 23 of the Act;

*audit fee (including time to close out corrective action requests – non conformance audits)* means the fee payable to DFSV for an audit of a licensee’s food safety program(s) under section 41(1) of the Act.
- 3) This instrument comes into effect on 1 July 2024.
- 4) For the avoidance of doubt, this instrument supersedes any previous instrument in which DFSV has determined licence classes and fees for dairy businesses.
