MINISTERIAL ORDER NO. 1455

Order Amending Ministerial Order No. 1425 – Victorian Institute of Teaching Registration Fees
The Minister for Education makes the following Order –

1. Title

This Order may be cited as Ministerial Order No. 1455 – *Order Amending Ministerial Order No. 1425 – Victorian Institute of Teaching Registration Fees*.

2. Purpose

This Order amends Ministerial Order No. 1425 – *Victorian Institute of Teaching Registration Fees* (Ministerial Order No. 1425), made by the Minister for Education on 20 August 2023 to fix new fee rates for existing fees charged by the Victorian Institute of Teaching, including teacher and early childhood teacher registration fees, and to fix fees in relation to continuing education programs, for the period 1 September 2024 to 31 August 2025.

3. Authorising provision

This Order is made under sections 2.6.77(1) and 5.10.4(1) of, and Clause 3 of Schedule 6 to, the **Education and Training Reform Act 2006**.

4. Commencement

This Order commences on 1 September 2024.

5. Clause 4 substituted

For Clause 4 of Ministerial Order No. 1425 **substitute** –

‘The fees in Clause 5 are for a 12-month period commencing 1 September 2024.’.

6. Clause 5 substituted

For Clause 5 of Ministerial Order No. 1425 **substitute** –

‘The following fees are fixed pursuant to section 2.6.77 of the Act:

Initial registration (applicants with Victorian qualifications) / permission to teach pursuant to sections 2.6.7(2), 2.6.12A(2)* and 2.6.13(2)	\$165.87
Initial registration (applicants with interstate or overseas qualifications)/permission to teach pursuant to sections 2.6.7(2) and 2.6.13(2)*	\$191.83
Application for second registration pursuant to sections 2.6.7(2), 2.6.12A(2) and 2.6.77A	\$39.49
Annual registration/renewal of registration if paid by 30 September pursuant to sections 2.6.18 and 2.6.21**	\$124.12
Annual registration/renewal of registration if paid from 1 October to 31 December which incorporates the late processing fee/additional fee pursuant to sections 2.6.18 and 2.6.21**	\$163.62
Annual registration /Renewal of registration for second registration pursuant to sections 2.6.18, 2.6.21 and 2.6.77A**	\$28.21
National criminal history check (known as the Nationally Coordinated Criminal History Check) pursuant to section 2.6.22A(3)	\$73.12
Late processing fee/additional fee pursuant to sections 2.6.18 and 2.6.21	\$39.49
Replacement of registration card processing fee pursuant to section 2.6.4(2)(g)	\$28.21

Statement of good standing pursuant to section 2.6.4(2)(g)	\$56.42

** The annual registration fee is payable where registration is not due for renewal. In all other cases the renewal fee applies.'
