ROAD DECLARATIONS

Head, Transport for Victoria, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares the roads described in the Schedule and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE

ARTERIAL ROAD

- a) That part of Hoddle Highway identified by hatching on the plan numbered GP23888 is declared as described in the legend in the said plan.
- b) That part of South Gippsland Highway identified by hatching on the plan numbered GP20717A is declared as described in the legend in the said plan.

EFFECTS ON ROAD NAMES

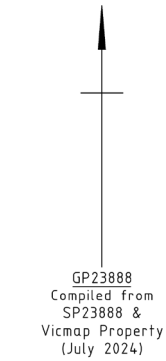
1. Names in Column 2 are existing Vicmap Address names, which are unaffected by this notice.

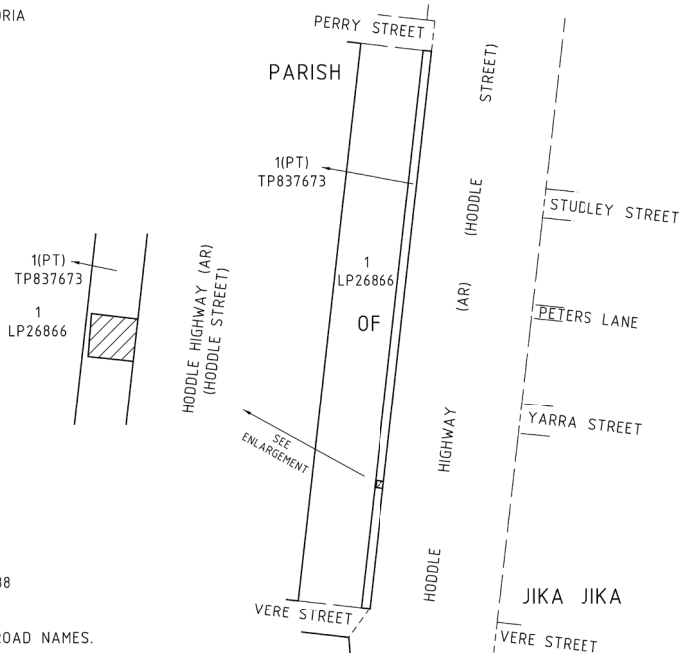

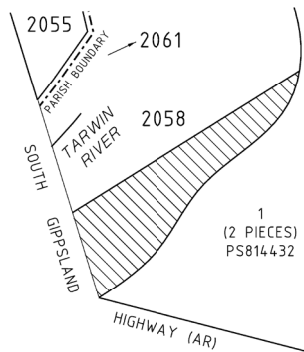

 SOUTH GIPPSLAND SHIRE

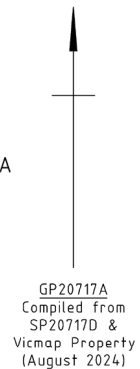
