### Marine Safety Act 2010

#### ORDER REVOKING AND APPOINTING PERSONS OR BODIES TO BE WATERWAY MANAGERS IN RESPECT OF SPECIFIED STATE WATERS

I, Steve Dimopoulos MP, Minister for Outdoor Recreation, make the following Orders with effect from the date of publication of this Notice in the Victoria Government Gazette.

- Pursuant to section 6(1) of the **Marine Safety Act 2010**, I hereby revoke the appointments of the persons or bodies listed in Column 1 of Table 1 to be a waterway manager in respect of the State waters specified opposite the name of the waterway manager in Column 2 of Table 1. The appointments that are revoked were made on 18 June 2012 and published in the Victoria Government Gazette No. S 220 on 28 June 2012.

The appointment amends the Notice published in the Victoria Government Gazette No. S 220 on 28 June 2012. The appointment is for a period of 5 (five) years under section 6(4) of the **Marine Safety Act 2010** from the date of publication of this Notice in the Victoria Government Gazette.
