#### NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

The following replaces the notice advertised in the Victoria Government Gazette No. G 45 dated 24 October 2024 page 2215.

Parks Victoria as the declared waterway manager for Yarra River upstream of port waters of the Port of Melbourne hereby gives notice under section 208(2) of the **Marine Safety Act 2010** that all persons and vessels not registered to take part in Rowing Victoria's 2024 Melbourne Head Regatta are prohibited from entering and remaining in the following waters.

Waters of the Yarra River – between the Monash Freeway Bridge to a straight line between the upstream edge of Federation Wharf to Mercantile Rowing Shed.

The exclusion zone will be in effect from 7.30 am to 5.00 pm on Saturday 16 November 2024.

#### Set-Aside Determination – Regulation 11(1)
