MILDURA AND SWAN HILL PLANNING SCHEMES

Notice of Approval of Amendment

Amendment GC202

The Minister for Planning has approved Amendment GC202 to the Mildura and Swan Hill Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment applies the Specific Controls Overlay to land approximately 30 kilometres upstream of the Euston Weir near Robinvale and approximately 75 kilometres south of Mildura in north-west Victoria to facilitate the use and development of land for the Belsar-Yungera Floodplain Restoration Project and the Hattah Lakes North Floodplain Restoration Project. The Minister for Planning will be responsible for administering the changes made by the Amendment.
