## Order Amending Employment Ministerial Orders

(Ministerial Order No. 1388, Ministerial Order No. 1389 and Ministerial Order No. 1451)

I, Ben Carroll, Minister for Education and Minister responsible for administering the **Education and Training Reform Act 2006** make this Order, which is to be cited as Ministerial Order No. 1409 – Order Amending Employment Ministerial Orders (Ministerial Order No. 1388, Ministerial Order No. 1389 and Ministerial Order No. 1451).

**Part 1 – Preliminary****1. Purpose**

This Order amends:

- (a) Ministerial Order No. 1388 – Teaching Service (Employment Conditions, Salaries, Allowances, Selection and Conduct) Order 2022 (Ministerial Order No. 1388) to:
  - (i) facilitate the payment of superannuation contributions for the first 52 weeks of an employee’s parental absence where they are the primary caregiver and to provide the method for calculating the quantum of superannuation contributions payable;
  - (ii) extend the period of maternity leave for which an employee may elect to receive half pay from 28 weeks to 32 weeks;
  - (iii) revoke redundant vaccination requirements; and
  - (iv) make other minor and technical amendments.
- (b) Ministerial Order No. 1389 – School Council Employees (Employment Conditions, Salaries, Allowances, Selection and Conduct) Order 2022 (Ministerial Order No. 1389) to:
  - (i) specify the reasons a person can be employed on a fixed term basis;
  - (ii) enable payment to a Casual Relief Teacher who works in excess of 7.6 hours on any day;
  - (iii) facilitate the payment of superannuation contributions for the first 52 weeks of an employee’s parental absence where they are the primary caregiver and to provide the method for calculating the quantum of superannuation contributions payable;
  - (iv) extend the period of maternity leave for which an employee may elect to receive half pay from 28 weeks to 32 weeks;
  - (v) revoke redundant vaccination requirements;
  - (vi) clarify the operation of employment limitations; and
  - (vii) make other minor and technical amendments.
- (c) Ministerial Order No. 1451 – Victorian Curriculum and Assessment Authority Employees (Employment Conditions, Salaries, Allowances, Selection and Conduct) Order (Ministerial Order 1451) to:
  - (i) clarify the operation of employment limitations; and
  - (ii) enable the Victorian Curriculum and Assessment Authority (the Authority) to employ staff for additional purposes.

**2. Authorising Provisions**

This Order is made under sections 2.3.8, 2.5.5(1A), Part 2.4 and sections 5.10.4 and 5.10.5 and item 8 of Schedule 6 to the **Education and Training Reform Act 2006**.

**3. Commencement**

This Order commences on the date it is signed.

**Part 2 – Amendments to Ministerial Order 1388****4. Amendment to clause 6.10.12**

For clause 6.10.12, **substitute** –

- ‘6.10.12 (1) Notwithstanding clause 6.10.1, where the pregnancy of an employee terminates or results in a stillborn birth after:
- (a) more than 12 weeks but less than 20 weeks, the employee will be entitled to an unpaid absence of six months following the termination, or such longer period as may be medically certified; or
  - (b) more than 20 weeks, the employee will be entitled to an unpaid absence of twelve months following the termination, inclusive of any period of maternity leave. If the employee and the Secretary agree, an employee can extend a period of unpaid absence by up to an additional 12 months.’

**5. Amendment to Division 10, Part 6**

After clause 6.10.12, **insert** –

- ‘6.10.13 (1) An employee is entitled to have superannuation contributions made in respect of the period of the employee’s parental absence for which they are the primary caregiver which occurs on or after 25 July 2022.
- (2) The Secretary will pay the superannuation contributions as a lump sum to the employee’s superannuation fund.
  - (3) The quantum of superannuation contributions payable under this clause will be calculated based on:
    - (a) the number of weeks of the employee’s parental absence for which they are the primary caregiver, capped at 52 weeks;
    - (b) the employee’s normal rate of pay; and
    - (c) the applicable contribution rate under the **Superannuation Guarantee Administration Act 1992** (Cth) at the time the payment is made.
  - (4) Payment will be made at the conclusion of the 52-week period for which the employee is the primary caregiver, provided the employee continues to be employed at that time. This does not preclude payments during the 52-week period where this is operationally more efficient for the Employer.’

**5. Amendment to clause 6.11.2**

In clause 6.11.2(2):

- (a) after ‘6.11.1’ **insert** ‘by’;
- (b) for ‘28 weeks’ (wherever occurring) **substitute** ‘32 weeks’; and
- (c) for ‘14 weeks’ **substitute** ‘16 weeks’.

**6. Revocation of Part 11A**

Part 11A is **revoked**.

**7. Amendments to Schedule 1**

- (a) In the second row of the column (headed 1/10/20) of the table in clause 1.1(4), for ‘1/10/20’ **substitute** ‘1/01/25’.
- (b) In the second row of the column (headed 1/01/25) of the table in clause 1.1(4), for ‘1/01/25’ **substitute** ‘1/07/25’.
- (c) In the second row of the final column (headed 1/01/25) of the table in clause 1.1(5), for ‘1/01/25’ **substitute** ‘1/07/25’.

**Part 3 – Amendments to Ministerial Order 1389****8. Amendments to clause 1.1.4**

After clause 1.1.4(9), **insert** –

‘(9A) **‘employment limitation’** means an employment limitation imposed by the Secretary under Ministerial Order No. 1388 – Teaching Service (Employment Conditions, Salaries, Allowances, Selection and Conduct) Order 2022;’.

**9. Amendments to clause 2.4.2**

(a) In clause 2.4.2(1)(a), after ‘rate’ **insert** ‘or part thereof’.

(b) Clause 2.4.2(1)(b) is **revoked**.

(c) For clause 2.4.2(2), **substitute** –

‘(2) (a) For the first 7.6 hours of employment on any day, the payment calculated under subclause (1) will not exceed the maximum payment set out in clause 1.2(2) of schedule 1.

(b) For any employment in excess of 7.6 hours on any day, casual relief teachers will be paid the hourly rate calculated under subclause (1).’.

**10. Amendments to clause 2.4.4**

After clause 2.4.4(2), **insert** –

‘(3) In circumstances where a casual relief teacher is employed to work more than 7.6 hours they cannot be required to work more than five hours without an unpaid break of 30 minutes free from assigned duties.

(4) A School Council may only cancel casual relief teacher services by 12.00 pm the day before the casual relief teacher’s shift is to commence (Cancellation Time) by providing written notice to the casual relief teacher. If the School Council cancels casual relief teacher services after the Cancellation Time, then the relevant casual relief teacher rate for the cancelled casual relief teacher services will be payable by the School Council (Cancellation Fee). A Cancellation Fee will not be payable where an alternative shift is provided to the affected casual relief teacher.’.

**11. Amendment to clause 3.1.1**

(2) After clause 3.1.1(1), **insert** –

‘(1A) The council may only employ employees on a fixed term basis in the following circumstances:

(b) Subject to subparagraphs (c) and (d), when a person is employed for a fixed period of time to replace an employee during a parental absence, that person will be employed for seven years;

(c) If the employee absent on leave associated with a parental absence returns to duty or the employee’s period of fixed term employment expires, the replacement employee’s employment may cease prior to the expiration of the seven years only if the employee is provided with at least twelve weeks’ notice of termination;

(d) If the employee absent on leave associated with a parental absence is ongoing and does not return to duty at the school, the employee employed to replace the ongoing employee absent on leave associated with a parental absence will be offered ongoing employment subject to a probationary period;

- (e) When the council has a reasonable belief that a surplus staff situation will arise if a person is not employed on a fixed term basis provided that the period of the fixed term is less than two years;
- (f) When a person is employed for a fixed period of time not exceeding three years to undertake a specific project for which funding has been made available for a specified period of time of more than two years, provided that the vacancy is to be advertised for the duration of that funding and there are no reasonable prospects of the funding being renewed after the end of that period;
- (g) Other fixed term employment that would be permitted under the **Fair Work Act 2009** (Cth) or regulations made under that Act.’.

## 12. Substitution of clause 3.1.5

For clause 3.1.5, **substitute** –

‘3.1.5 If a person is subject to an employment limitation, that person’s eligibility for employment under Part 2.3 of the Act is subject to the terms and conditions of that employment limitation.

**Note:**

A person who is subject to an employment limitation that provides that they are prohibited from employment is ineligible for employment under this Order.

If a person is subject to an employment limitation that places a condition on their employment, but does not prohibit their employment entirely, they are eligible for employment as long as the condition is satisfied.’.

## 13. Amendment to clause 5.1.1

- (a) Clause 5.1.1(3) is **revoked**.
- (b) Clause 5.1.1(4)(d) is **revoked**.

## 14. Amendment to clause 5.1.6(1)

In clause 5.1.6(1), for ‘personal grievance in respect of a selection decision, an abandonment action, or an employment limitation internal review decision’ **substitute** ‘personal grievance in respect of a selection decision or an abandonment action’.

The Essential Services Commission (the Commission) gives notice under section 40FBB of the **Electricity Industry Act 2000** that it has determined the rates for purchases of small renewable energy generation electricity by a relevant licensee from a customer who is a relevant generator.

For time-varying rates option 2 – Shoulder times are for 9.00 pm to 10.00 am and from 2.00 pm to 4.00 pm every day. Off peak time is 10.00 am to 2.00 pm daily. Peak time is 4.00 pm to 9.00 pm daily.

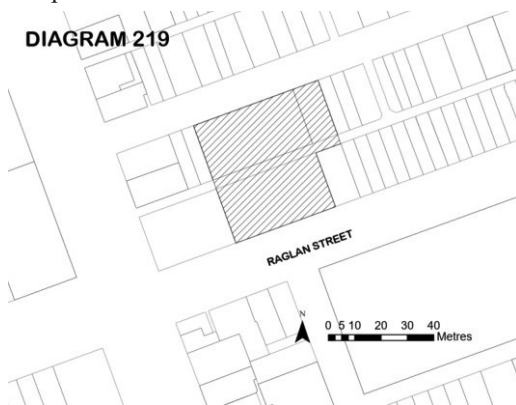

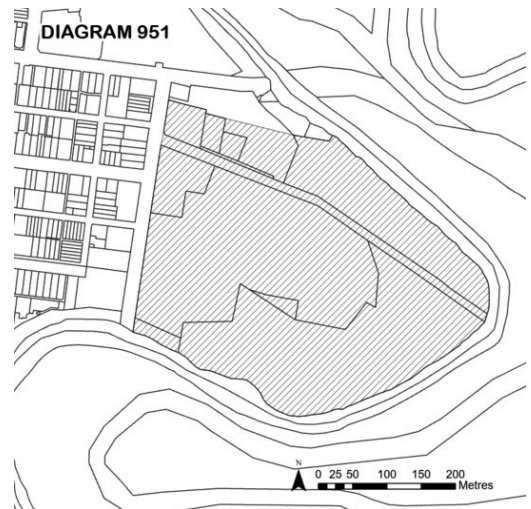
