### ROAD DECLARATIONS

Head, Transport for Victoria, pursuant to section 14 of the **Road Management Act 2004**, upon publication of this notice declares and revokes the roads described in the Schedule and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

### SCHEDULE

#### ARTERIAL ROAD

- a) That part of Wy Yung Road identified by hatching on the plan numbered GP25197 as described in the legend in the said plan.

#### MUNICIPAL ROAD

- b) Those parts of Riverine Street and Service Street identified by hatching on the plan numbered GP25197A is declared as described in the legend of the said plan.
