## Major Transport Projects Facilitation Act 2009

### REVOCATION OF TEMPORARY RESERVATION OF CROWN LAND AND CROWN GRANT IN FEE SIMPLE

Order in Council

The Governor in Council under section 139(2) of the **Major Transport Projects Facilitation Act 2009**, revokes the temporary reservation for Melbourne Metro Rail Project purposes of the land identified in the Schedule (**Underground Land**) and grants this Underground Land to the project authority, here the Secretary to the Department of Transport and Planning, in fee simple (with no depth limitation and without consideration) pursuant to section 142B of the **Major Transport Projects Facilitation Act 2009**.
