### ROAD DECLARATION AND CLASSIFICATION

I, Jim Waller, Executive Project Director, Victorian Infrastructure Delivery Authority, as delegate of the Secretary to the Department of Transport and Planning who is the project authority for the West Gate Tunnel Project, in accordance with sections 193(1)(a) and 194(1) of the **Major Transport Projects Facilitation Act 2009**, upon publication of this notice in the Government Gazette, declare the land described in the Schedule and depicted in the plan attached to be road, and classified as municipal road.

The effect of this Road Declaration on road names is described in Table 1.

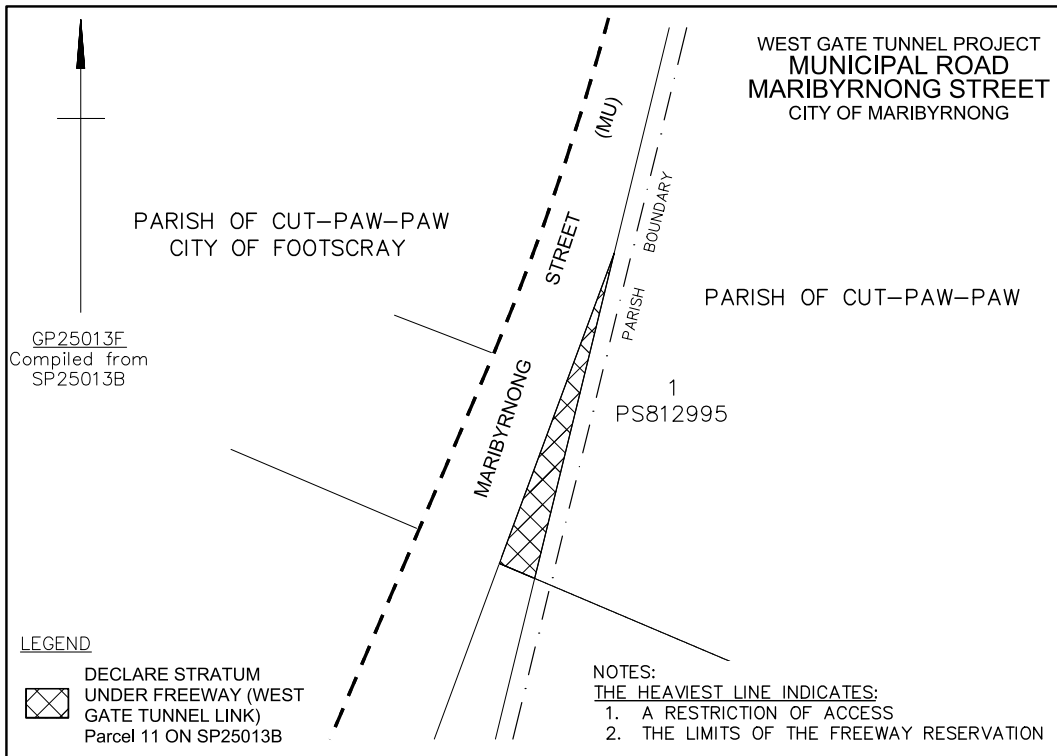
