LAND CONSERVATION (VEHICLE CONTROL) REGULATIONS 2024

Set-Aside Determination – Neerim Trailbike Network

Steve Dimopoulos, Minister for Environment and Ros Spence, Minister for Agriculture, on the recommendation of the public land manager, make the following determination to set aside the area described in clause 1 as a restricted access area under regulation 9(1)(a) of the Regulations for the use and operation of off-road motorcycles.

1. Set-aside area

The Neerim trailbike network approximately located as shown on the map in the Schedule is the set-aside area.

2. Access to the restricted access area

2.1. Subject to clause 3, a person may use or operate an off-road motorcycle in the restricted access area –

2.1.1. on a weekday, between the hours of 7.00 am or sunrise (whichever is later) and 8.00 pm or sunset (whichever is earlier) and not outside of these hours; and

2.1.2. on a weekend day, between the hours of 9.00 am and 8.00 pm or sunset (whichever is earlier) and not outside of these hours.

3. Conditions

3.1 The off-road motorcycle must be registered.

3.2 Any person operating an off-road motorcycle within the restricted access area must –

3.2.1 comply with the requirements of any signs displayed within the restricted access area including any signs that indicate a required direction of travel; and

3.2.2 not operate the off-road motorcycle on any trail within the restricted access area that is closed where that closure is clearly indicated by signage or barricades or other similar method.

4. Application and commencement

4.1. This determination applies at all times that the determination is in force.

4.2. This determination commences on the day that it is published in the Government Gazette and remains in force until revoked.

5. Definitions

The following definitions apply in this determination –

corresponding law means a law of another State or of a Territory that corresponds to Division 2 of Part 2 of the **Road Safety Act 1986**;

off-road motorcycle means a two-wheeled motorcycle designed primarily for off-road use;

registered means registered under Part 2 of the **Road Safety Act 1986** or a corresponding law;

Regulations means the Land Conservation (Vehicle Control) Regulations 2024;

restricted access area means the area of land specified in clause 1 of this determination as the set-aside area.

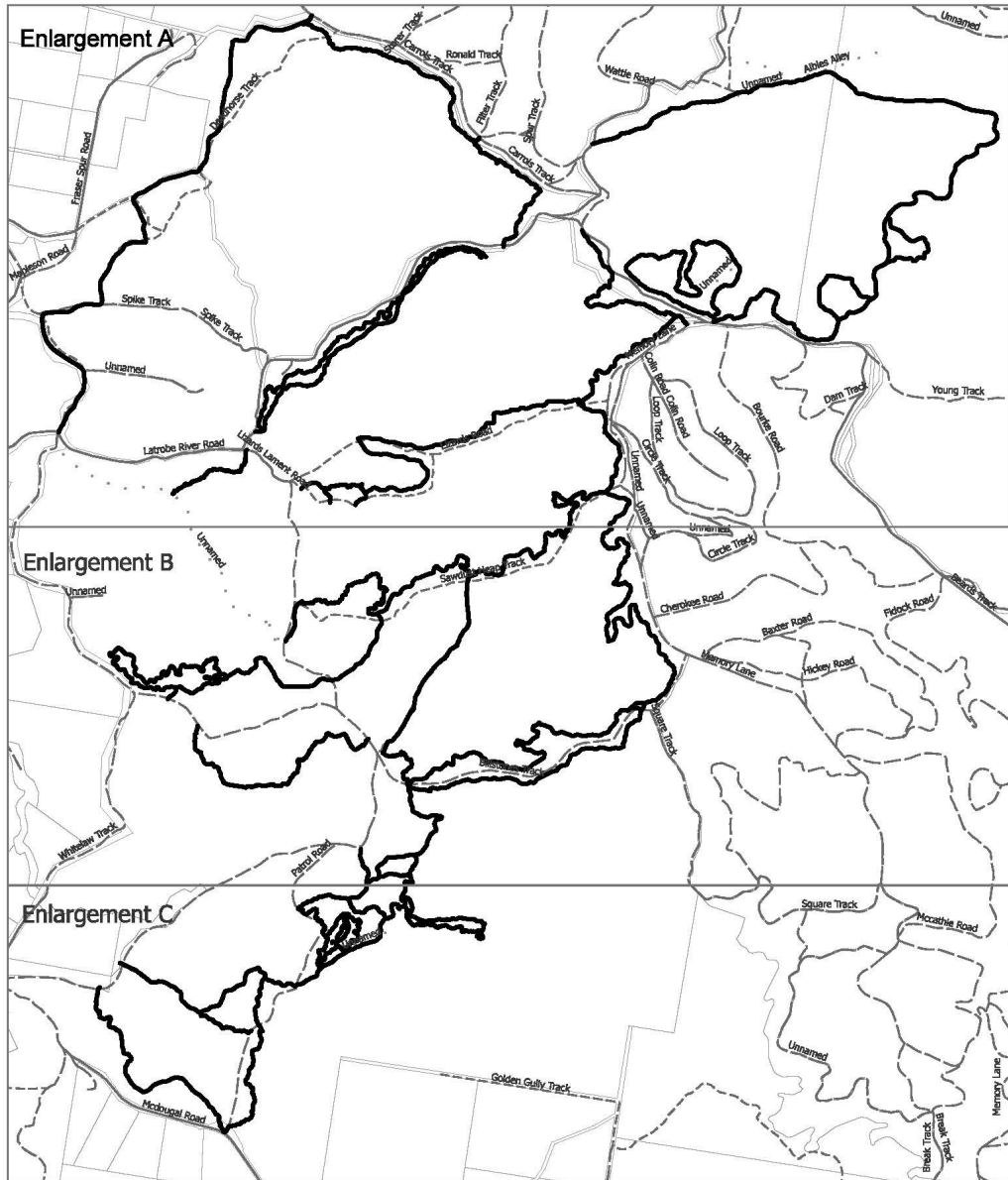
Notes:

1. To ride in a state forest, you must hold a motorcycle licence or learner's permit.
2. It is an offence under regulation 11 of the Regulations for a vehicle other than a motorcycle to be operated or used in the set-aside area (10 penalty units).
3. It is an offence under regulation 12(1) and (2) of the Regulations to use, operate, stop, park or leave a vehicle on public land in a manner that damages that land (20 penalty units).
4. It is an offence under regulation 13 of the Regulations to use the restricted access area declared by this determination in a manner that contravenes any conditions of this set-aside determination (5 penalty units).

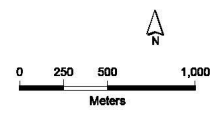
SCHEDULE Map

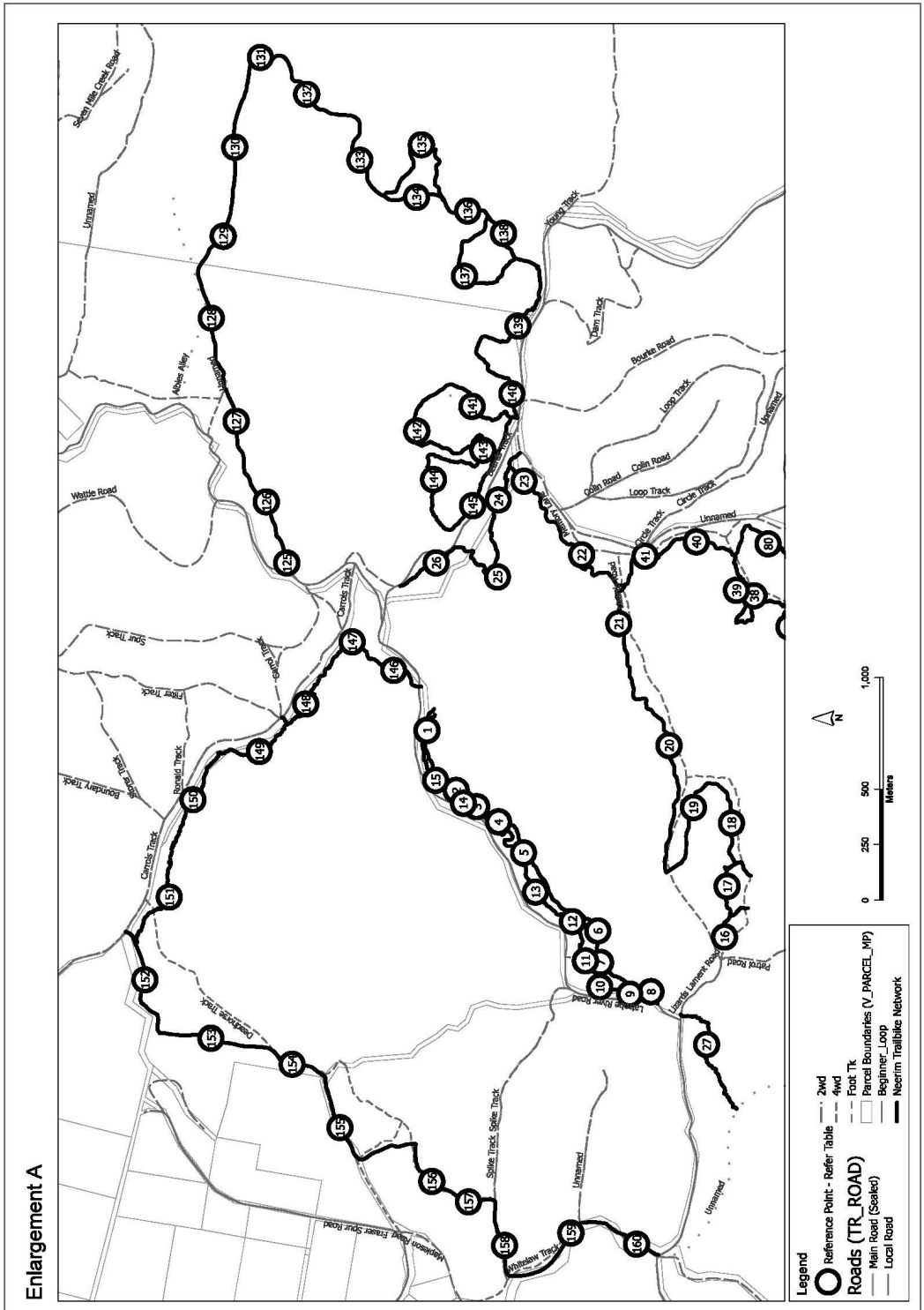
Neerim Trailbike Network

- ▬ Neerim Trailbike Network



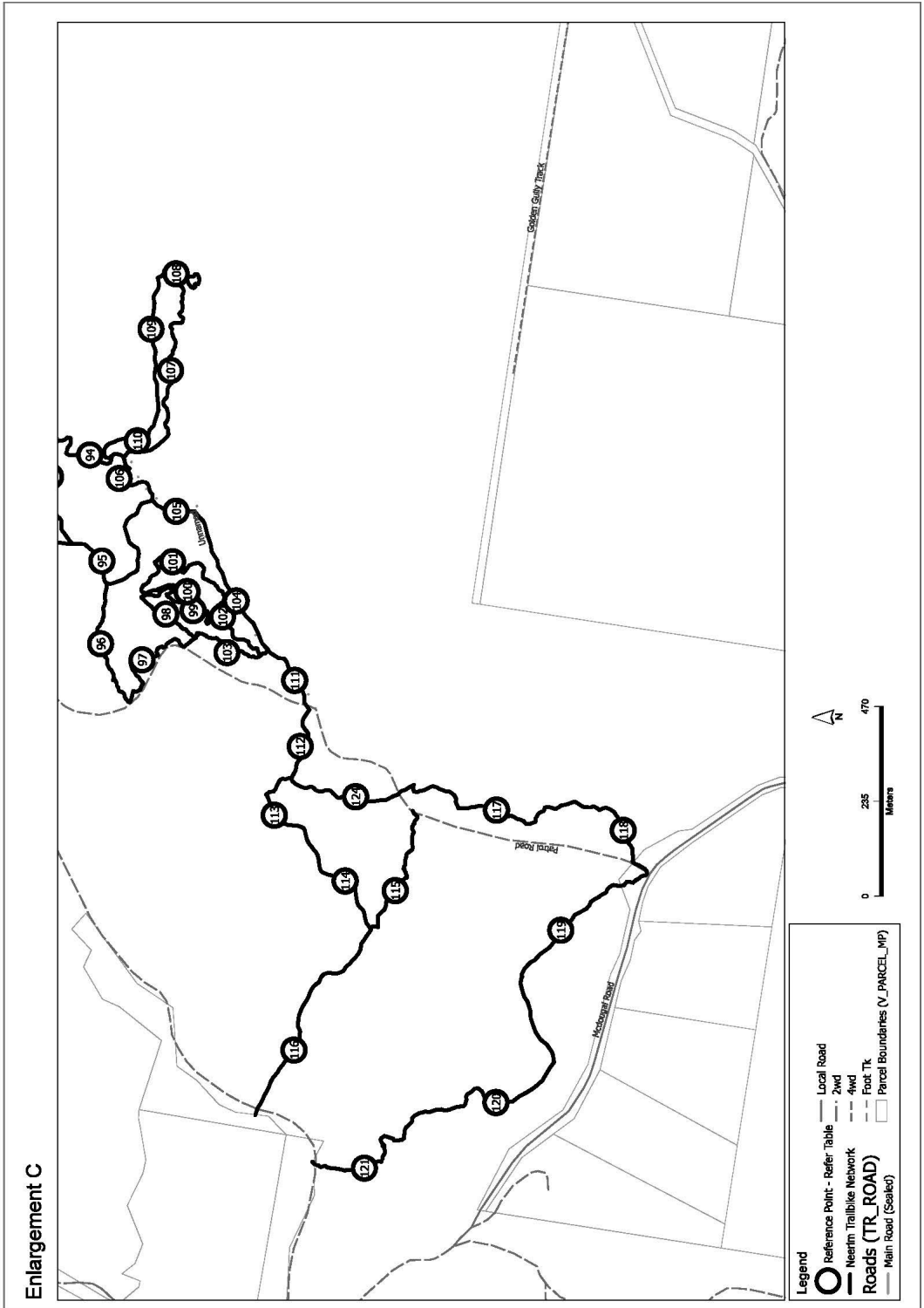
