| | (4) If Part 5 does not come into operation before 1 July 2028, it comes into operation on that day. |
| 13/2026 | (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed. |
| | (2) If a provision of this Act does not come into operation before 1 July 2026, it comes into operation on that day. |
| 14/2026 | (1) This Act (other than Parts 3, 6 and 8, Divisions 5, 6, 7 and 8 of Part 4 and sections 33 and 43) comes into operation on the day after the day on which this Act receives the Royal Assent. |
| | (2) Subject to subsection (3), Parts 3, 6 and 8, Divisions 5, 6, 7 and 8 of Part 4 and sections 33 and 43 come into operation on a day or days to be proclaimed. |
| | (3) If a provision referred to in subsection (2) does not come into operation before 1 November 2026, it comes into operation on that day. |
| 15/2026 | (1) This Act (other than Parts 2, 4 and 9) comes into operation on the day after the day on which it receives the Royal Assent. |
| | (2) Subject to subsections (3), (4) and (5), Parts 2, 4 and 9 come into operation on a day or days to be proclaimed. |
| | (3) If a provision of Part 2 does not come into operation before 1 July 2026, it comes into operation on that day. |
| | (4) If a provision of Part 4 does not come into operation before 31 July 2026, it comes into operation on that day. |
| | (5) If a provision of Part 9 does not come into operation before 1 September 2026, it comes into operation on that day. |
