NOTICE SPECIFYING AN ACTIVITY EXCLUSION ZONE

I, Nick Antonopoulos, Senior Safety Assurance Officer, acting in my capacity as delegate of Safe Transport Victoria, pursuant to section 208(1) of the **Marine Safety Act 2010** by this notice prohibit:

- all persons, other than members, officers or personnel of Victoria Police, Victoria State Emergency Service, Victorian Fisheries Authority, Strathbogie Shire Council and Safe Transport Victoria, and
- all vessels, other than those operated by Victoria Police, Victoria State Emergency Service, Victorian Fisheries Authority, Strathbogie Shire Council and Safe Transport Victoria, and vessels expressly authorised by members, officers or personnel of Victoria Police, Victoria State Emergency Service, Victorian Fisheries Authority, Strathbogie Shire Council and Safe Transport Victoria

from entering, or remaining in, the following State waters:

- Goulburn River, 100 metres upstream and downstream of Chinamans Bridge.

This notice comes into effect at 12.00 am on Wednesday 1 July 2026 and remains in effect until 12.00 am Thursday 31 December 2026, or until revoked.
